

## AGREEMENT

This agreement made and entered into this the \_\_\_\_ day of \_\_\_\_\_, 2011, by and between ST. JOSEPH'S PEACE MISSION FOR CHILDREN, INC., of Owensboro, KY, and the OHIO COUNTY FISCAL COURT, of Hartford, Kentucky, by and through David Johnston, Judge Executive, herein after County;

WHEREAS, ST. JOSEPH'S PEACE MISSION FOR CHILDREN, INC. maintains an emergency shelter facility in Owensboro, Kentucky, known as ST. JOSEPH'S PEACE MISSION FOR CHILDREN, for the temporary placement of juveniles; and

WHEREAS, the County is financially responsible for placement of juveniles by the District Court in the event they are not committed to the Cabinet of Human Resources;

NOW, THEREFORE, for and in consideration of the county paying \$49.00 per day per child and ST. JOSEPH'S PEACE MISSION FOR CHILDREN providing its facilities to the County, the parties agree to the following terms and conditions:

1. That the County will pay ST. JOSEPH'S PEACE MISSION FOR CHILDREN upon receipt of billing statements reflecting the number of children in care for the County and the number of days in care.
2. That ST. JOSEPH'S PEACE MISSION FOR CHILDREN will maintain its facility in compliance with all state regulations and provide for all the reasonable needs of the children while being cared for by ST. JOSEPH'S PEACE MISSION FOR CHILDREN.
3. The County will be responsible for transportation of the child to and from ST. JOSEPH'S PEACE MISSION FOR CHILDREN, and for payment of necessary medical and psychological services.
4. All children accepted and cared for at ST. JOSEPH'S PEACE MISSION FOR CHILDREN will be maintained at the shelter strictly pursuant to its intake criteria.
