#### BOYD COUNTY SCHOOL DISTRICT

#### DISTRICT FACILITIES HEARING REPORT

A public hearing was held at the Boyd County Middle School on September 25, 2012, at 5:30 p.m. (local time). The purpose of the public hearing was to propose a new District Facility Plan developed by the Boyd County Local Planning Committee. The Local Planning Committee (LPC) voted 15-0 in favor of the proposed new plan and the Board voted 4-0 to approve the new plan.

There were six persons at the hearing exclusive of the hearing officer, in attendance. Mike Oder, KSBA Facilitator served as the locally-appointed hearing officer. Howard Osborne, Superintendent, Jim Taylor, LPC member, Brock Walter, Central Office staff, Don Fleu, Central Office staff, William Burdette, BSA and Ryan Bloomfield, WSAZ was present.

#### **COMMENTS**

Howard Osborne, Boyd County Superintendent called the public hearing to order. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 4:180. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes:

#### New construction of Career and Technical Center

# Major renovation including ADA & Life Safety and new construction at:

- Boyd County Middle School including site, exterior, roof, HVAC and interior.
  Expansion of media center and kitchen and renovation of science labs. New construction includes: 4 special education resource rooms and 1 computer room.
- Cannonsburg Elementary School including site, roof, HVAC, exterior and interior, electrical, plumbing, restrooms, media center and kitchen. New construction includes: 2 preschool rooms and administrative addition.
- Catlettsburg Elementary School including site, roof, HVAC, exterior, interior, plumbing and expansion of cafeteria. New construction includes: custodial receiving.
- Ponderosa Elementary School including roof, HVAC and cafeteria expansion. New construction includes: 2 preschool rooms, 1 family resource center, 1 computer classroom and 1 administrative addition.
- Summit Elementary School new construction includes: 5 special education resource rooms and 2 preschool rooms.
- Construct a new central bus garage and major renovations to the central office and maintenance facility
- Discretionary projects include Phase III site development at the new Boyd County High School.

The floor was opened to those who wished to make a statement. No statements were made.

# RECOMMENDATIONS

It is recommended that the new District Facility Plan developed by the Boyd County Local Planning Committee and adopted by the Boyd County Board of Education be approved as the District Facility Plan for the Boyd County School District. A copy of the new plan is attached.
