# <u>Russell Independent</u> SCHOOL DISTRICT DISTRCT FACILITIES PLAN HEARING REPORT\*

A public hearing was held at the Russell Independent Middle on September 24, 2012, at 6;30 (local time). The purpose of the public hearing was to propose a new District Facility Plan developed by the Russell Independent Local Planning Committee. The Local Planning Committee (LPC) voted 11 in favor (8 absent) of the proposed new plan and the Board voted 5 in favor to approve the new plan.

There was/were 8 district employees and three board members in attendance. Larry Woods, KSBA Consultant, served as the locally-appointed hearing officer. There were no community members and no media present.

### COMMENTS

Larry Woods called the public hearing to order. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 1:001. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes;

- A. No projects proposed in 2012-2014 Biennium
- B. Proposed projects in 2014-2016:2b. New High School (10-12) Renovations at:
  - 1. Existing Russell High School to become 6-9 Middle School.
  - 2. Existing Russell Middle School to become 4-5 Intermediate School
  - 3. Existing Russell-McDowell Intermediate to become Central Office, Alternate School, and Early Childhood Center2c. Major
  - 4. Russell Area Technology Center

Capital Construction Projects:

- 1. Central Bus Garage
- 2. Central Office on 2<sup>nd</sup> Floor of Russell McDowell

#### **Discretionary Projects**

- 1. Remedial repairs at Russell Primary
- 2. Site Improvements at Russell-McDowell Intermediate
- 3. District White Board Initiatives
