- 9 NECESSITY, FUNCTION, AND CONFORMITY: KRS 156.029 (7) indicates the primary
- 10 function of the Kentucky Board of Education (KBE) is to adopt policies and administrative
- regulations by which the Kentucky Department of Education shall be governed in planning and
- 12 operating programs within their jurisdiction. KRS 156.070 (5) requires the board, upon the
- 13 recommendation of the Commissioner of Education, to establish policy or act on all programs,
- services and other matters which are within the administrative responsibility of the Department.
- 15 KRS 158.6453 (3) (a) vests in the KBE the responsibility to create an assessment system that
- measures achievement of the state learning goals, ensures compliance with the federal No Child
- 17 Left Behind Act of 2001, 20 U.S.C. secs. 6301 et. seq. (NCLB) and ensures school
- accountability. KRS 158.6455 requires the KBE to create an accountability system to classify
- schools and districts, and to establish appropriate consequences for schools failing to meet their
- 20 accountability measures. KRS 160.346 requires the KBE to promulgate administrative

- 1 regulations to establish the process for implementing school interventions and alternate
- 2 management options for schools, districts, and the state for persistently low-achieving schools,
- 3 now identified as priority schools. In order to obtain approval of Kentucky's ESEA Flexibility
- 4 Waiver, which allows flexibility from specific requirements of NCLB, the USDE requires the
- 5 KBE to identify the state's lowest-achieving schools (formerly called persistently low-achieving
- 6 schools) as priority schools, and for those priority schools to follow the requirements of 20 USC
- 7 6301, Section 1003 (g) regarding school intervention options. This administrative regulation
- 8 establishes the process and procedures for implementing school interventions and alternate
- 9 governance options for priority schools and districts.
- 10 Section 1. Definitions.
- 11 (1) "Annual measurable objective (AMO)" is defined in 703 KAR 5:225 and means the
- improvement goal for each school or district calculated from the overall score.
- 13 (2) "District leadership review" is [means] an assessment, described in KRS 160.346, of the
- 14 [functioning of the] school district's ability to manage an intervention in that school,
- including [for] districts containing a priority school. [, a determination of the district's ability
- 16 to manage an intervention in that school.
- 17 (3) "District[s] that contains a priority school" is a [means] district[s] that has [have] not been
- identified as a priority district[s] but that has in its [have in their] jurisdiction one or more
- 19 priority schools.
- 20 (4) "Leadership review process" is [means] the review and audit process required under KRS
- 21 158.6455 and 158.346 to establish appropriate consequences for priority schools, districts
- containing priority schools, and priority districts as defined in 703 KAR 5:225.

- 1 (5) "Leadership review team" is [means] a team approved by the Commissioner of Education to
- 2 conduct a school or district leadership review required by KRS 160.346.
- 3 (6) "Persistently low-achieving school" is defined in KRS 160.346.
- 4 (7) "Priority school" is defined in 703 KAR 5:225[7] and is [means] a school that has been
- 5 identified as a persistently low-achieving school pursuant to KRS 160.346.
- 6 (8) "Priority district" is defined in 703 KAR 5:225 and is [means] a district that has an overall
- 7 score in the bottom five (5) percent of overall scores for all districts that have failed to meet the
- 8 annual measurable objective for the last three consecutive years.
- 9 (9) "School leadership review" is [means an assessment] described in KRS 160.346, and is an
- 10 **assessment** of the functioning of the school, including
- 11 (a) a determination of the capacity of a principal and [or] school council to lead an intervention
- option in a priority school;
- 13 (b) [and] a recommendation by the leadership review team as to whether or not the council and
- principal have capacity to lead the school to recovery, or should be replaced.
- 15 (10) "School intervention" is defined in KRS 160.346.
- 16 Section 2. Leadership review team selection and membership. (1) Members of the leadership
- 17 review team shall be selected by the Department, and approved by the commissioner or his
- or her designee from qualified applicants [approved by the Department]. The team members
- shall complete Department-provided or -approved training in any areas needed to effectively
- 20 perform their duties. Members shall hold appropriate certification or qualifications for the
- 21 position being represented, and the team shall not include any members currently employed by
- the district or school under review.

- 1 (2) The team shall be approved by the commissioner or his **or her** designee and shall include the
- 2 following representation:
- 3 (a) The chairperson, who shall be designated by the Department or its' designee, shall be
- 4 <u>1. A</u>n experienced administrator <u>employed</u> [approved] by the Department to provide highly
- 5 skilled education assistance as required by KRS 158.782;
- 6 2. An experienced certified administrator member of the audit team; or
- 7 <u>3. A</u> similarly qualified state-designated professional [to serve as chairperson].
- 8 The chair may serve in addition to the six (6) members outlined in (b) through (g), or may
- 9 be selected from those one of those six (6) members who also meets the qualifications of this
- 10 paragraph.
- 11 (b) An individual **employed** [selected] by the Department to provide highly skilled education
- 12 assistance as required by KRS 158.782;
- 13 (c) A teacher who is actively teaching or has taught within the last three years;
- 14 (d) A principal who is currently serving or has served as a principal within the last three
- 15 **years**;
- 16 (e) A district level administrator who is currently serving or has served in a district
- administrative position within the last three years;
- 18 (f) A parent or legal guardian of [who has or has had] a school-aged child; and
- 19 (g) A university representative who is currently serving or has served in that capacity within
- the last three years.

- 1 Section 3. School Leadership Review (1) Within ninety (90) days of identification as a priority
- 2 school by the Department, a school leadership review shall be scheduled to review the
- 3 functioning of the school council and the specific leadership capacity of the principal.

- 5 the school shall be based upon an assessment of capacity in the following areas:

- 17 that generates a range of data about student learning and system effectiveness and uses the
- 18 results to guide continuous improvement.
- 19 (3) The determination of the school council's ability to lead the intervention in the school
- shall be based upon an assessment of capacity in the following areas:
- (a) Purpose and direction supporting high expectations for all students;
- 22 (b) Effective governance and leadership systems and processes

14	makes <u>:</u>

- 1 (c) Scores [score] at or above a seventy (70) percent graduation rate for three consecutive years.
- 2 Section 4. District Leadership Review. (1) Within ninety (90) days of identification by the KDE
- 3 as a district containing a priority school, or as a priority district, a district leadership review shall
- 4 be scheduled to review the functioning of the district administration and its specific leadership
- 5 capacity related to each identified school.
- 6 (2) The determination of the district's ability to manage the intervention in the priority school
- 7 shall be based upon an assessment of capacity in the following areas:
- 8 (a) Purpose and direction supporting high expectations for all students;
- 9 (b) Effective governance and leadership systems and processes
- 10 (c) Curriculum, instructional design and delivery that ensure both teacher effectiveness and

- working conditions surveys and student satisfaction surveys; administration of the "Missing"
- 20 Piece of the Proficiency Puzzle, June 2007" as well as other methods that may be required to
- 21 obtain the necessary information.

- 1 (4) Following the review, a report shall be submitted to the commissioner that specifically makes
- 2 a recommendation regarding whether the district has the capability and capacity to manage the
- 3 intervention in the identified school(s).
- 4 (5) There shall be only one (1) district leadership review per district, per year, regardless of the
- 5 number of priority schools located in the district.
- 6 (6) A district leadership assessment shall be repeated as often as the commissioner deems
- 7 necessary, based on student achievement scores, progress on implementation of the
- 8 comprehensive district improvement plan (CDIP) and other factors related to student
- 9 achievement.
- 10 Section 5. Notification to Schools and Districts of Leadership Assessment Determination. (1)
- After completion of the leadership reviews and within thirty (30) days of receipt of the reports,
- the commissioner shall notify in writing the school council, principal, superintendent, and local
- board of education of the determination regarding:
- 14 (a) School council **capacity and** authority;
- 15 (b) Principal capacity and authority; and
- 16 (c) District capacity and authority.
- 17 (2) The notification shall include a statement of the appeal process to the KBE as required by
- 18 KRS 160.346. The commissioner shall make the final report publicly available.
- 19 Section 6. Authority to Select an Intervention Option. (1) If the school leadership review
- determines that the school council has sufficient capacity to manage the recovery, and the district
- 21 leadership review determines the district has the capacity to support the recovery, the school
- council shall, within thirty (30) days after the receipt of the commissioner's notification, choose

- an intervention option pursuant to KRS 160.346 and develop an action plan. The council shall
- 2 present the option and plan to the local board of education, which shall give final approval and
- 3 provide the necessary support and resources for the recovery effort.
- 4 (2) If the school leadership review determines that the school council does not have sufficient
- 5 capacity to manage the recovery and recommends the council's **role become advisory**
- 6 [authority be transferred] and the district leadership review finds sufficient district capacity to
- 7 support the recovery and recommends the council's authority be transferred to the
- 8 superintendent, the superintendent shall, within forty-five (45) days after the receipt of the
- 9 commissioner's notification or thirty (30) days after the action of the KBE if an appeal is filed,
- make a recommendation for an intervention option and submit the choice to the local board of
- education, which shall make the final determination on the intervention option
- 12 (3) If the school leadership review determines that the school council has sufficient capacity to
- manage the recovery, and the district leadership review determines the district does not have the
- 14 capacity to support the recovery, the school council shall, within thirty (30) days after the receipt
- of the commissioner's notification or thirty (30) days after the action of the KBE if an appeal is
- filed, choose the intervention option and submit its choice to the local board of education, which
- shall review the option chosen by the school council and submit the choice to the commissioner
- who shall approve the choice.
- 19 (4) If the school leadership review determines that the school council does not have sufficient
- capacity to manage the recovery and recommends the council's **role become advisory**
- 21 [authority be transferred], and the district leadership review finds the district lacks sufficient
- capacity to support the recovery and recommends the council's authority be transferred to the

- 1 commissioner, the commissioner shall, within forty-five (45) days after receipt of these
- 2 determinations and in consultation with the advisory school council, superintendent and local
- 3 board of education, determine the intervention option. The identified school and local district
- 4 shall implement the intervention option with support from the Department.

- When the commissioner is required to appoint advisory school council members, he shall

- 10 (2) He shall select candidates who are capable of providing leadership in the turnaround
- environment of the school, and meet the requirements of KRS 160.345.

- 20 (e) Provide staff with ongoing, high-quality, job-embedded professional development that is
- 21 aligned with the school's comprehensive instructional program and designed with school staff to

- 1 ensure they are equipped to facilitate effective teaching and learning and have the capacity to
- 2 successfully implement school reform strategies which shall include:
- 3 1. Subject-specific pedagogy;
- 4 2. Instruction that reflects a deeper understanding of the community served by the school; and
- 5 3. Differentiated instruction;
- 6 (f) Implement strategies designed to increase opportunities for career growth which shall include
- 7 more flexible working conditions designed to recruit, place, and retain staff with the skills
- 8 necessary to meet the needs of the students in a transformation school;
- 9 (g) Use data to identify and implement an instructional program that is research-based and
- vertically aligned from one (1) grade to the next as well as aligned with state academic standards;
- 11 (h) Promote the continuous use of student data from formative, interim, and summative
- 12 assessments to inform and differentiate instruction in order to meet the academic needs of
- individual students;
- 14 (i) Increase learning time and create community-oriented schools that:
- 15 1. Establish schedules and implement strategies that provide increased learning time; and
- 16 2. Provide ongoing mechanisms for family and community engagement;
- 17 (j) Provide operational flexibility and sustained support that:
- 18 1. Gives the school sufficient operational flexibility, including staffing, calendar, time, and
- budgeting to fully implement a comprehensive approach to substantially improve student
- achievement outcomes and increase high school graduation rates; and
- 2. Ensures that the school participates in ongoing, intensive technical assistance and related
- support from the local district and the state; and

- 1 (k) Provide quarterly progress reports to the local board of education and the Department.
- 2 (4) A school or district engaging in the School Closure Option shall develop a plan for the
- 3 closure of the school. The plan shall include:
- 4 (a) A process for the transfer of students to higher performing schools in the district;
- 5 (b) A determination by the local board of education regarding staff assignments and the use of
- 6 the existing facility and other assets;
- 7 (c) A method of monitoring the progress of students in their new school environment; and
- 8 (d) A quarterly progress report to the local board of education and the Department.
- 9 Section **9** [8]. Establishment of Approved External Management Organizations. (1) The list of
- approved EMOs shall be created by the commissioner following the application process
- established in subsection (2) of this section.
- 12 (2) The commissioner shall issue a request for information to solicit EMO applicants who shall
- detail the scope of the services they are able to provide to a persistently low-achieving school.
- 14 The request for information shall include the following information to solicit the EMO's
- 15 qualifications:
- 16 (a) The ability of the EMO to staff the school with dynamic leadership with experience in turning
- around low-performing schools during the period of the contract;
- 18 (b) The ability of the EMO to conduct a needs assessment in the school and develop a plan of
- action based on the needs assessment;
- 20 (c) The ability of the EMO to deliver a comprehensive list of services designed to turnaround the
- 21 school(s);
- 22 (d) The ability of the EMO to screen staff and make decisions on staff assignments;

- 1 (e) Its familiarity with Kentucky school laws and administrative regulations;
- 2 (f) The experience of the EMO in turning around low-achieving schools;
- 3 (g) References from other low-achieving schools or school districts supporting the EMO's ability
- 4 to turn around low-achieving schools;
- 5 (h) Evidence by the EMO that its provision of services includes instructional leadership,
- 6 professional learning support for teachers and other staff, and services to families and
- 7 community stakeholders;
- 8 (i) Evidence of the EMO's financial stability, any pending or threatened litigation, and liability
- 9 insurance coverage; and
- 10 (j) Other information required pursuant to KRS Chapter 45A.
- 11 (3) The commissioner shall review all responses and determine which applicants meet the
- criteria in subsection (2) of this section. The qualifying applicants shall be submitted to the KBE
- for approval. The list of approved EMOs shall be made public upon approval by the KBE.
- 14 [Section 9. Replacement of council members by the Commissioner of Education. (1) When
- 15 the commissioner is required to appoint advisory council members, he shall select three (3)
- 16 teachers and two (2) parents from a list of nominees submitted by the superintendent.
- 17 (2) He shall select candidates who are capable of providing leadership in the turnaround
- 18 environment of the school, and meet the requirements of KRS 160.345.
- 19 (3) The appointed council shall remain in advisory capacity until the school meets the
- 20 requirements of KRS 160.346(8)
- 21 (4) The commissioner shall fill any subsequent vacancy through this procedure, until such
- 22 time as full authority is restored to the council.]
