**McLEAN COUNTY SCHOOL DISTRICT
DISTRICT FACILITIES PLAN HEARING REPORT***

A public hearing was held at the McLean County Board of Education on September 5, 2013, at 5:31 PM CDT. The purpose of the public hearing was to propose a new District Facility Plan developed by the McLean County Local Planning Committee. The Local Planning Committee (LPC) voted 13-0 in favor of the proposed new plan and the Board voted 5-0 to approve the new plan.

There was/were (3) three people at the hearing exclusive of the hearing officer in attendance. Butch Canty of the Kentucky School Boards Association, served as the locally-appointed hearing officer. Present for this meeting was the chairman of Local Planning Committee (Steve Riggs), the board representative Wendell Miller, finance officer (David Stokes).

COMMENTS

Hearing Officer Butch Canty called the public hearing to order. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 1:001. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes; A plan of organization of **PS-5, 6-8, 9-12**. All school centers in the plan are permanent centers. There are no projects listed in **Priority Number One: Priority Number Two: Major Renovations in 2c at McLean Co. High School, Calhoun Elementary, Livermore Elementary, Sacramento Elementary School, 2e. District wide security upgrades and entrance vestibules..** There are no projects in **Priority Number Three. Priority Number Four** has construct a McLean Co. Central Office facility and Maintenance/Central Storage Building. Major Renovations at the Central Bus Garage. **Priority Number Five:** has projects at McLean Co. High School football beachers and McLean Co. Middle School site drainage and parking repairs.

The floor was opened to those who wished to make a statement. There was no written statements submitted to the school district and no oral comments made at the meeting. Those present thought this McLean Co. Draft Facilities Plan was a good plan for the district.

RECOMMENDATIONS

It is recommended that the new District Facility Plan developed by the McLean County Local Planning Committee and adopted by the McLean County Board of Education be approved as the District Facility Plan for the McLean County School District. A copy of the new plan is attached.
