# VII.B. Update on Student Assignment Process

Dr. Bob Rodosky, chief of Data Management, Planning, and Program Evaluation; and Dr. Dena Dossett, director of Planning and Program Evaluation, provided an update on activities to improve the customer service and efficiency of student assignment and outlined next steps for additional improvements. Jonathan Lowe, director of Student Assignment, and Dr. Kathy McGinnis, director of Optional/Magnet Programs, also participated in the discussion. Each Board member had an opportunity to comment and ask questions.

Chair Porter requested the entrance criteria for all magnet programs, who has the authority to change the criteria, and what the process is for changing the criteria.

# VII.C. 2013–14 Board of Education Discussion Agenda Planning Calendar

- Dr. Hargens noted that a Draft 2013–14 Year-at-a-Glance Planning Calendar was included in the red folders and requested that Board members provide any feedback and suggestions to her.
- Mrs. Duncan requested the monthly suspensions report. Dr. Hargens stated the report is on the Data Dashboard and she will provide the information monthly during her report.
- Mrs. Duncan requested an annual safety report that would include discipline and suspension data.
- Mr. Jones stated that he is still confused about how the Board makes suggestions and how they close the loop on what their plan is. "It's hard to get insight—at least for me—to get insight into what's coming."
- Mr. Brady asked about the procedure for adding items to the agenda. Chair Porter suggested that he provide the information to the Superintendent and Chair.
- Mr. Jones reiterated that he remains very confused about the calendars. "We have a planning calendar and then we have a calendar that shows our actual plan, and I find that very confusing. I would like to see them united into one—one thing that shows what's coming in the meetings."
- Chair Porter: "And let me just say that we continue to hear that and we continue to work on it—and Dr. Hargens is still working on it as well. But what she has given you is a year-at-a-glance to get an idea of what the year has looked like for us. That is not the planning calendar—that is a year-at-a-glance."
- Mrs. Wesslund requested a report on teacher recruitment, training, and support and how the Professional Educator Growth System is working.
- Mrs. Wesslund requested a report on how discipline is being handled in the schools and how schools follow the Code of Conduct. "By no means am I getting lots and lots of concerns, but I'm getting more this year than I have ever had before from parents about students in a number of schools, in a number of kinds of situations...There is still this threat of increased reporting about discipline. And then I hear that we can't suspend kids even when it is a significant issue, and that's concerning to educators...discipline is an important part of education. And whether children have trouble or not, we've got to at some point have an environment where everybody can learn."
- Mrs. Haddad: "I agree with Mrs. Wesslund because I'm getting calls too that they're told not to suspend. I think there's some point you have to suspend when things are happening. So, I think that really needs to be looked at. I don't know where it's coming from. I know we have things in place that can handle some situations, but not all situations. So, we have to be sure we keep the schools safe and not just have a good record that we're not suspending. We don't want to suspend them; we want them in school, but we have to be sure that we have safe schools too."

- Mrs. Duncan: "I agree with that. I'm getting situations too that I hear about that are very difficult for principals because, somehow or other, expectations are being put out there that they are not to suspend kids. They're to put up with a lot more, and even in one case somebody being told they didn't have to follow the discipline code on a particular thing. I think we have a safety report—we're supposed to have a safety report annually. Maybe in that safety report we can include data about our discipline and our offenses. You know, I don't care about reducing suspensions if the offenses are still there. We want to reduce the offenses, and that's what we hope that all these programs will do—to help kids so they'll behave better."
- Mr. Jones: "I hate to keep beating a dead horse, but we have two different agendas for the December 9 meeting. I don't think it is unreasonable for the Board members to know what is coming two weeks from today.
- Board members continued the discussion concerning the 2013–14 Board of Education Discussion Agenda Planning Calendar, the 2013–14 Draft Year-at-a-Glance Calendar, and the timeline and process for providing materials to Board members.
