**SHELBY COUNTY SCHOOL DISTRICT
LOCAL/STATE BOARD FACILITIES HEARING REPORT**

A Local/State public hearing was held at the Shelby County Board of Education Office on April 15, 2014, at 6:00 p.m. (local time). The purpose of the public hearing was to propose a new District Facility Plan developed by the Shelby County Local Planning Committee. The Local Planning Committee (LPC) voted 16-0 in favor of the proposed new plan and the Board voted 5-0 to approve the new plan.

There was/were **0** individuals in attendance. Kerry Whitehouse, Assistant Superintendent served as the district-appointed hearing officer.

COMMENTS

Mr. Whitehouse called the public hearing to order and outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 4:180. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes;

NEW CONSTRUCTION –

- **construction of a 2 new schools**
 - **a 600 student elementary school on or near the Discovery Blvd. Campus.**
 - **an 800 student middle school to initially house P-8 on or near the Discovery Blvd Campus.**
- **a new 75 student alternative school or explore moving the alternative program into existing middle and high schools or renovate existing facility.**
- **Constructing JROTC classrooms, indoor shooting range, and greenhouse on MLCHS campus.**

ADDITIONS/RENOVATIONS –

- **Wright Elementary renovations to include reconfiguring current art, music, computer lab and media center.**
- **East Middle renovations to include media center, gym and cafeteria.**
- **Heritage Elementary renovations to include HVAC, fire alarm, roof, and expansion of kitchen and cafeteria.**
- **SCHS to include renovation of 1960 and 1992 sections for HVAC and plumbing. Renovate agriculture, carpentry and other spaces.**
- **Simpsonville Elementary renovations to include windows, roof and parking.**
- **Painted Stone Elementary renovations to include energy efficiency, parking, bus and car traffic entrances and sidewalks.**
- **Area Technology Center renovation to 1968 portion to include windows, lighting and plumbing, or renovate another existing facility. Construct additional classrooms and labs on current SCATC campus.**
- **Improvements and additions to the Bus Garage and Maintenance Building.**
- **District-wide renovations to include: ADA compliance, safety and security upgrades.**

DISCRETIONARY PROJECTS -

The plan includes upgrade at all current facilities for 21st Century Learning, outdoor classrooms at Painted Stone Elementary and Clear Creek Elementary, and tennis courts at Martha Layne Collins High School.

The floor was opened to those who wished to make a statement. No comments were made.

RECOMMENDATIONS

It is recommended that the new District Facility Plan developed by the Shelby County Local Planning Committee and adopted by the Shelby County Board of Education be approved as the District Facility Plan for the Shelby County School District. A copy of the new plan is attached.
