## SAFETY AND SECURITY MEASURES AND COLLABORATION

January 2013-October 2013	Department of Law Enforcement personnel taught twenty-two inservice classes at the Lexington Police Department. This was in regard to lockdown/active shooter/student reunification.
January 2, 2013	A meeting was held with school directors in reference to conducting lockdown/active shooting presentations to all school employees.
February 18, 2013	Department of Law Enforcement Director and Associate Director attended an active shooting presentation at the Western Hills High Schools in Frankfort.
Spring 2013	Active shooting presentations were given to staff at each of our schools.
School Year 2013-14	Hand held ballistic shields were purchased for each of our area offices.
June 3, 2013	Active shooter training for Department of Law Enforcement officers was conducted at one of our high schools.
June 4, 2013	Lockdown and Safety review was conducted for Booker T. Washington's summer camp program.
July 3, 2013	Department of Law Enforcement officers participated in active shooter training at Lexington Police Department's firing range.
August 12, 2013	Lockdown presentation for food services workers
August 12, 2013	Collaborative effort with Bluegrass Crime Stoppers Board to have anti-bullying posters placed on every Fayette County Public School bus. So far, Department of Law Enforcement has received twelve calls which were investigated or referred to the appropriate school.
School Year 2013-14	Lockdown drills were completed in each of our schools within the first thirty days of the beginning of school and within the first 30 days after winter break. The Lexington Fire Department also participated for the first time.

September 5, 2013	Department of Law Enforcement Director presented "Youth and Firearms" at the Conference on Youth Violence Summit. A total of nine Department officers attended the summit.
September 10, 2013	Director and Associate Director attended FBI active shooter training.
October 29, 2013	Department of Law Enforcement Director gave a presentation at the UK Martin School of Public Safety Policy and Management Institute for government officials of the Democratic Republic of Korea. The topic of this presentation was school safety and youth violence.
May 14, 2014	A presentation was given at the District Leadership Meeting concerning "Lessons Learned from Sandy Hook"
June 12, 2014	Department of Law Enforcement officers participated in a joint active shooter training with Lexington Police Department's Emergency Response Unit at one of our high schools.
June 16, 2014	A Reunification Committee was established consisting of principals, IAKSS personnel and law enforcement in order to develop a student reunification plan to address student reunification with families after a natural/human made crisis at our schools.
July 2, 2014	Lexington Police Department's Emergency Response Unit used one of our high schools for active shooting training.
August 2014	Lockdown meetings and trainings are being conducted with our educational partner sites that are not Fayette County Public Schools property, but house our students and staff.
School Year 2014-15	Scheduling and completion of all lockdown drills will be completed in compliance with state law.
Ongoing	Department of Law Enforcement officers have either already attended or will be scheduled to attend Crisis Intervention Training or Law Enforcement Response to Special Needs Persons trainings. This will better enable our officers to effectively and safely interact with persons with psychiatric disabilities.

Summer 2014	Department of Law Enforcement has made several visits to schools in the past few months that have requested assistance in examining locks and issues related to lockdown situations.
Beginning 2014-15	Department of Law Enforcement officers will focus on a

heightened awareness for suspicious persons, circumstances, or objects in or around our schools.
