## **Supporting Effective Educator Development (SEED)**

The first meeting of the Kentucky Network to Transform Teaching (KyNT3), created in response to the Supporting Effective Educator Development Grant (SEED), which is a collaborative effort between the Kentucky Education Association (KEA), Kentucky Department of Education (KDE) and EPSB, was held on September 29, 2014. The event was well attended by both state and national education leaders. Kentucky's eight member KyNT3 team, representatives from the National Board for Professional Teaching Standards, members of the statewide NT3 Advisory Council, Kentucky National Board Certified Teachers, Kentucky General Assembly representatives and Governor Steve Beshear's office, charted the future of the KyNT3. ## **Kentucky Core Academic Standards Challenge**

The Kentucky Department of Education, in cooperation with education advocacy groups across the state, kicked off the Kentucky Core Academic Standards Challenge, a process for collecting feedback on the English/language arts and mathematics standards adopted in 2010. The standards represent the level of knowledge and expected skill application for K-12 public school students at each grade level. Between now and April 30, 2015, P-12 teachers, higher education representatives, parents, students and others who are interested can go to <a href="http://kentucky.statestandards.org">http://kentucky.statestandards.org</a> to read the grade level standards in English/language arts and mathematics and provide their response. The standards are searchable by subject, grade level and key word. Participants may make suggestions about moving the standard to another grade level, splitting the standard, creating a new standard or rewriting the standard as it currently exists.

## **LEAD Reports due Soon**

Districts are reminded that October is the month during which the LEAD report must be corrected, completed, and submitted to EPSB. November 1, 2014, is the sign-off date, but districts may sign off earlier if all errors have been corrected. Superintendents should take a moment this month to speak with the LEAD coordinators and view the Preliminary Audit Report, which will show any critical errors such as out-of-field teachers, new teachers not yet in KTIP, and those with expired certificates. ## **Kentucky Teacher Internship Program (KTIP)**

As of August 28, 2014, EPSB staff members have approved 2,441 internships. To ensure new teachers are provided opportunity to complete KTIP during the first-year, budget bill language has once again allowed for reducing out-of-class hours to 40 mentoring hours for 2014 - 2105.

## **Background Checks for all New Educators**

Beginning January 1, 2015, all applicants for a first-time teaching certificate in Kentucky will need to submit a criminal background check with their applications for certification. Since this is a new requirement, the EPSB has chosen to use the same background check required for employment or student teaching in Kentucky to avoid additional expenses for the applicants and the school districts.

Student teachers may submit a copy of the background check required by the school district in KRS 160.380(5) to meet this new requirement. For school districts, this means that your student teachers will be requesting a copy of their background checks from you prior to applying for certification. The EPSB asks that if you have any questions concerning providing copies of the background checks to student teachers that you contact Alicia Sneed at Alicia.Sneed@ky.gov.

Additionally, districts will need to provide copies of background checks to the EPSB when applying on the behalf of individuals for first-time emergency substitute certificates, temporary provisional certificates, and emergency certificates. The EPSB only needs a copy of the background check necessary for employment and this is only for individuals who are not currently certified in Kentucky. We know that districts hire individuals on a probationary basis while awaiting the background check, but once the background check is received the EPSB will need a copy to finalize the application process for each individual.

The transition process will begin in January in order to help staff minimize problems that might be experienced by our school districts and educator preparation programs. Please check the *EPSB Update Memo* over the next few months for additional information regarding the new background check requirements.
