## **Football Bracketing Discussion**

The Commissioner presented data and options for discussion concerning future football playoff pairings, including a review of past changes.

# **Baseball Tournament Scheduling and alternatives**

Following a review of data since the change in the baseball state format to sixteen teams, and in strong consideration of data presented by a member school regarding the impact of pitching limitations on the member schools qualifying, staff discussed with Lexington Legends, the host venue of the state tournament, on possible schedule revisions. Changing the schedule to allow for time to reset pitching limitations could be allowed by tournament play on successive weekends.

#### **Baseball Pitch Count**

Staff presented the Board with Sports Medicine based research including play at other levels that provided information showing that a pitch count limitation is likely a much better risk and injury minimization strategy than the long-existent innings pitched limitations.

With this data available and recommendations from sports medicine and research bodies, it is apparent that taking a leadership position in this discussion and enacting a pitching limitation based on pitch count is a preferred method of minimizing the incidence of pitching related injuries due to overuse.

As such, staff recommended the adoption of a pitch count limitation for 2016 to replace the innings limitation contained in the current competition rules.

Further discussion suggested the model limitation presented also contain middle school recommendations. It is the option to adopt the limitation across the board for all ages, or to present the middle school limitation to the Middle School Advisory Committee for their separate consideration

## **Region and State Tennis Revisions**

The Kentucky Medical Association Sports Medicine Committee, acting on a report from the USTA, the governing body for Youth and Adult Tennis in the US, has recommended that youth players play no more than two full set matches in a day. Due to this recommendation being made, Commissioner Tackett asks the Board to consider schedule revisions to ensure that team and individual singles and doubles play are not conducted simultaneously during the event.

There also exists a discrepancy between the process to declare a regional Team Champion and a State Team Champion. At this time, the regional champion is determined by aggregate points earned in singles and doubles play while the state champion awards are given based on a seven-player team vs. team competition.

The Commissioner and staff have worked closely with the members of the Tennis Advisory Committee to address those issues and reach resolution.
