- (a) What this administrative regulation does: KRS 156.070 requires the Kentucky Board of Education (KBE) to manage and control the common schools, including interscholastic athletics in the schools, and authorizes the KBE to designate an agency to manage athletics. This regulation designates the Kentucky High School Athletic Association (KHSAA) as the agent to manage high school and middle school interscholastic athletics, and incorporates by reference the bylaws, procedures and rules governing interscholastic sports.
- (b) The necessity of this administrative regulation: This regulation is necessary to designate the agency to provide the day-to-day management activities of interscholastic athletics in Kentucky; to set forth the financial, planning and review processes governing the agent; and to incorporate by reference the bylaws, procedures and rules of the agency.
- (c) How this administrative regulation conforms to the content of the authorizing statutes: The regulation designates the agency to manage interscholastic athletics, as authorized by the authorizing statute, and outlines the conditions under which this authority is granted.
- (d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: It designates the KHSAA as the agent to manage interscholastic athletics in the schools and districts at the high school and middle school levels, and publishes changes in bylaws, procedures and rules for affected schools and districts.
- (2) If this is an amendment to an existing administrative regulation, provide a brief summary of:
- (a) How the amendment will change this existing administrative regulation: These amendments make changes to the documents incorporated by reference, in the KHSAA Bylaw 6 as adopted by the KHSAA Delegate Assembly.
- (b) The necessity of the amendment to this administrative regulation: Pursuant to the KHSAA Constitution, which is incorporated by reference in this regulation, the members are required to have an annual meeting to discuss and recommend any needed changes to the Constitution and Bylaws. While they are not required to make changes to the Constitution and Bylaws, changes must be made through this process. This amendment incorporates changes approved at the annual meeting of the Delegate Assembly. This amendment also is necessary to designate the KHSAA as the agent to manage interscholastic athletics at the middle school level.
- (c) How the amendment conforms to the content of the authorizing statutes: The statute authorizes the KBE to designate an agency to manage interscholastic athletics in the common

schools. The regulation designates the KHSAA as that agent at both the high school and middle school levels, and incorporates by reference the KHSAA Handbook, which consists of the KHSAA Constitution, Bylaws, and Due Process Procedure to provide rules and guidance to the member schools and districts governing sporting events. The amendments in the Bylaws are made annually, according to the process outlined in the Constitution, and reflect input given by member schools and districts on changes that need to be made to provide a more sound structure of governance.

- (d) How the amendment will assist in the effective administration of the statutes: See (c) above.
- (3) List the type and number of individuals, businesses, organizations, or state and local governments affected by this administrative regulation: 174 School Districts
- (4) Provide an assessment of how the above group or groups will be impacted by either the implementation of this administrative regulation, if new, or by the change if it is an amendment: There will be little impact because of the nature of the changes to the regulation. There are requirements that continue to be placed on schools and coaching personnel, however the training required to meet these requirements will be provided at no costs to the schools or the coaching personnel.

- (a) Initially: Minimal
- (b) On a continuing basis: None

SUMMARY OF CHANGES TO MATERIAL INCORPORATED BY REFERENCE

REVISIONS:

KHSAA Bylaws, 23 pages:

Substantive changes to these materials include two proposals that were considered by the KHSAA member schools and passed. They include:

Proposal 2015-1, Bylaw 6, a revision regarding student athletes who change schools after participating in varsity athletics in the $9^{th} - 12^{th}$ grade. Any student who moves in with a coach, school staff, or team members could lead to ineligibility.

Proposal 2015-2, Bylaw 6, a revision to eliminate the applicability of the transfer rule in Bylaw 6 to students in the 4th through 8th grades.

Other non-substantive changes have been made in the form of technical revisions to correct drafting and formatting errors.

KHSAA Board of Control and Officials Division Policies, 46 pages:

Changes are being made to these materials in several sections. In the Penalty Policy, the penalties for the late submission of game statistics and the participation of coaches who have not taken the required sports safety course are now increased in severity.

The deadlines to enter teams into championships are also amended to recognize the Association's new sport activities including Bowling, Archery, and Bass Fishing. The possibility of adding Dance as a new activity is also included.

Pertaining to Officials and Assigning Secretaries, language clarifying the selection of a Assigning Secretary is the responsibility of the KHSAA and not the Policy Board and is done on an annual basis. The interview process of Assigning Secretaries by the Policy Boards has been clarified to require the interviews to be done in an open meeting environment. Further changes include the manner in which the Arbiter assigning system should be used.

For Officials, the deadline to register and take the required rules clinics have been adjusted. The ability to utilize a third party for the registration process has also been recognized by the policy. Officials who have been registered for over 25 years do not have to pay the normal licensing fee on an annual basis. This does not include the administrative fee for officials. Further changes to the Officials Policy no longer restricts basketball officials from working the district basketball tournament in their home district. Finally, while payment of officials at the contest is still allowed, this payment cannot be delivered directly by the coaches.

In the Sports Medicine Policies, the coach's role in evaluating concussions has been clarified. The application of the Heat Index has been clarified to require the measurement to be taken on site and that in multi-field complexes, all fields shall take the required breaks under the policy simultaneously. Emergency Action Plans and the requirements of KRS 160.445 have been recognized and the recommendations of the use of Automatic External Defibulators are made.

Further changes have been made recognizing these policies are board matters in accordance with the KHSAA Due Process Procedures. Finally, various technical revisions to correct drafting and formatting errors have also been made.

KHSAA Form BA101 - Baseball Pitching Limitation, 1 page:

This form was changed to recognize the new manner in which pitching is now tracked. Formerly, pitching was tracked by how many innings were pitched by any given pitcher. The new method tracks the specific number of pitches by the specific pitcher.

KHSAA Form GE07 - Transfer Form, Exchange Students, 3 pages:

This form was changed to add the list of approved agencies in accordance with Bylaw 7 to assist schools in providing information. Further changes were made to correct minor grammatical and formatting errors.

KHSAA Form GE08 - Transfer Form, Non-Exchange Students, 2 pages:

This form was changed to correct minor grammatical and formatting errors.

KHSAA Form GE16 - Request of Statutory Waiver of Bylaw 2, 1 page:

This form was changed to allow the form to be faxed or emailed for consideration. Various additional changed were made to correct minor grammatical and formatting errors as well as correct and update various statutory, regulatory, or bylaw references.

KHSAA Form GE36 - Add. Info for Appeal, 1 page:

This form was updated to recognize recent bylaw changes to Bylaw 3 that formerly recognized the date of promotion to grade eight (8) as the start of a student's eligibility for four consecutive years. The Bylaw now recognizes the initial enrollment into grade nine (9) as that starting point for the purpose of the four year period.

KHSAA Form GE69 - Waiver - 15 Day Exceptions, 1 page:

The form was changed to recognize that the Principal of the school is not the only person who can sign this waiver. The waiver may also be signed by the school's designated representative. The form can also be used by the family in this circumstance.
