# **Team Sports Items**

### Review and Discuss Sites for Future Events - Girls Basketball and Football

The Board had authorized the distribution of an RFP for the next five years of hosting girls' basketball as the tournament award expired in 2017. There were three cities presenting from: Bowling Green, Highland Heights, and Lexington (on behalf of Rupp Arena). Representatives making the presentations answered questions from the Board and Staff.

Additionally the Board had authorized staff to contract for hosting football final games at Western Kentucky University for 2015 through 2018, based on the schedule of games approved by the Board. In 2015 and 2016, the games were forced to move late in the season to an alternative (and less desirable) schedule. Following this, the Board approved the Commissioner look at alternatives.

With significant construction underway at the University of Louisville, to which would impact the fan experience in 2017, there was no bid submittal from Louisville and consideration was not given at this time.

Construction is currently also underway at Eastern Kentucky University and while anticipated to be complete in 2017, there are issues with the current site specifications as outlined when the Board last distributed an RFP (including opposite side seating requirements, etc.) and it was not considered at this time.

Currently, WKU is anticipating hosting the 2017 and 2018 championships but understands the position that the 2015 and 2016 schedule changes placed the KHSAA Board and staff in, particularly related to loss of revenue. In addition, changes on the horizon for Fruit of the Loom, parent company of Russell Athletic, mean that the existing sponsorship with Russell Athletic will sunset following the 2017 championships, regardless of Board action.

The Commissioner following consultation with the Board officers, invited both WKU representatives and representatives of the University of Kentucky to be available to the Board for a discussion about the football finals for the Board to determine if additional action was desired. Russell Athletic would not be the sponsor of the football championships for 2017 if they were not held in Bowling Green.

# Consider Cross Bracketing of Rounds 1 - 4, Football Class 2A, 3A and 4A (responses to survey)

At the request of the Board, the Commissioner surveyed the football playing member schools in Class 2A, 3A and 4A regarding the bracketing for the football playoffs. For the 2016 football playoffs, the bracketing was "cross-bracketed" in Class 5A to allow for different matchups each year and different paths to the finals. Feedback in the past from several schools in Class 5A indicated a strong desire to allow for the same situation as had existed in Class 6A.

The Board requested surveys in 2A, 3A and 4A to determine the desires of these schools. Class 1A, due to its limited field and existing travel issues as well as the past opinions expressed on behalf of those schools was not indicative of this desire. Class 1A schools have asked for consideration of a potentially different playoff system than the other five classes due to the extremely small nature of their system and the unique nature of concerns among those smallest 32 schools.

There was good response from the classes surveyed.

# **Vote Required for District Site Selection in Competition Rules**

The vote for site selection in a district tournament in the team sports of baseball, basketball, soccer, softball and volleyball has long been required to be unanimous. Some districts have not been able to do what is practical or administratively wise due to this requirement.

The KHSAA bylaws that govern are determined by majority vote, and it appears that this policy follows in keeping with that procedure.

# **Track Alignment Draft**

Alignment maps were used to demonstrate the current and prospective track and field alignments as the current alignment would expire following the 2017 track season.

A revised alignment was presented by the Commissioner that takes the teams currently competing in track and assigns 40% of them to Class 1A, 30% to Class 2A and 30% to Class 3A as was requested by the Board. This breakdown generally compensates for the disparate number of competitors available to the smaller schools and attempts to create a balance between region size. The enrollment breakdowns were based on a four-year average enrollment, also per the Board's request.

There were minimal class changes as evidenced by the school enrollment report. There have been adjustments made geographically in several cases, to attempt to address issues that have surfaced during this current alignment and to more closely align schools to normal boundaries in other sports.

Cross country schools who do not participate in track and field (almost all within the boundaries of Class 1A on the draft) were then added to the alignment based on geography. Doing so in this manner proved beneficial so as not to artificially inflate the number of schools in Class 1A and lead to track regions without enough competitors to fully field many events at postseason competition.

## **Discuss Revised Dues Structure, Tickets and Income**

Commissioner Tackett presented options for revisions to the dues structure for member schools of the KHSAA based on the needs of the Association to continue to be able to provide the highest level of services to its schools, including rules enforcement as necessary.

Current budgetary situations discourage the expected level of compliance by member schools. In addition, as championship revenue, particularly in the major events that have long funded the association continues to decline, the Commissioner finds the Association at a critical juncture in its ability to continue to provide the highest quality experience for the student-athletes, coaches, administrators and fans of these great events.

While other states charge different (and sometimes lesser dues amounts), those states also generally charge entry fees to association tournaments, which would undoubtedly lead to less participation. In addition, Kentucky remains the sole state that takes no revenue from postseason championships until the final round that it manages with its own staff. The Board and the Commissioner have long felt that keeping that money in the hands of the schools and requiring only one fixed amount of dues per year is a much better option to continue the high level of participation and the vital role that interscholastic athletics plays in the educational growth of Kentucky students. Other states also obtain lines of credit to borrow from financial institutions during their "low points" of the year, which thus far has not been necessary for Kentucky due to prudent management by staff and effective oversight by the Board.

Past data was presented, and a recommendation made, to strengthen and stabilize the Associations positions and ensure its current level of service to its members be maintained.

There has been no change in membership dues since 1995-96, more than twenty years ago.

**Motion Passed:** Accept the report and direct that dues in the amount listed in Option 2 of the attached chart be implemented, and the schools invoiced for the coming year. Board President Hawkins asked that it be noted in the record that this is the first dues increase in 22 years.
