### **Approve Replacement of 2012 Automobile**

The KHSAA qualifies for the purchase of automobiles for its Commissioner and Assistant Commissioners under State Price Contract provisions. The current stance had been to maintain the automobiles provided to the Association for the longest usable life period. By contract, an automobile is provided to the Commissioner. Automobiles are also provided by Board of Control policy to the Associate Commissioner and three Assistant Commissioners for their use on Association business. The Marketing Sales Director is also provided an automobile for her use on Association business. Each individual provided with an automobile has properly reported income through the payroll system.

The Association at this time owns three cars. The automobiles assigned to the Commissioner, Associate Commissioner Cope and Assistant Commissioner Bridenbaugh were purchased from Dutch's Chevy in Mt. Sterling.

The automobile driven by Ms. Bridenbaugh is fully owned, as is the automobile driven by Mr. Cope. Payments on these automobiles, when payments are required, are funded through a corporate partnership with Ted Cook Tire in London.

The automobiles provided to Assistant Commissioner Barren and Bilberry are provided by Dutch's Chevy/Ford through a corporate contract and the automobile assigned to Ms. Little is provided through a corporate contract with Tanner Chrysler in Clay City.

The useful life of the automobile assigned to Mr. Cope has neared its end and the Commissioner requests the replacement of that automobile at this time. Through state and manufacturer incentives, a highly desirable alternative was found with Tanner Chrysler and such purchase was recommended.
