This is the regional realignment plan (Regions 1-16).

Here are the positives:

- 1. Every team in Regions 1-4 are in the central time zone. Every team in regions 5-16 are in the eastern time zone.
- 2. 63 of 64 districts are four or five team districts.
- 3. Jefferson County comprises ALL of Regions 6-7, no other districts have to be at the mercy of the JCPS master schedule.
- 4. All schools/countys in Region 11 physically touch Fayette County

Other parts of the plan:

- 1. Woodford Co. goes to Region 12
- 2. FCHS, WHHS, FHS go to Region 8
- 3. Accounts for the entry of Great Crossings High School
