Little League Basketball and Facility Management Agreement

Between

The Nelson County Parks and Recreation Department/Nelson County Fiscal Court

And

Nelson County Board of Education

Background:

The Nelson County Parks and Recreation Department (NCPRD) along with the Nelson County Fiscal Court is fortunate to have volunteers and staff who execute youth sports programs on behalf of the NCPRD and the County. In this unique partnership, the NCPRD provides manpower, needed budget and resources to maintain quality sports programs for Nelson County. The main goal is to provide youth of Nelson County with the ability to participate in a youth basketball program where they can learn the game of basketball, learn good sportsmanship and the correct way to win and lose.

General:

- The Nelson County Parks and Recreational Department (NCPRD) agrees to provide a youth basketball program as a service for the youth of Nelson County. Grades 4th thru 6th
 The term of this Agreement will begin _______ and continue through ______. A new agreement must be signed annually. Either party may terminate this agreement, provided written notice is given at least thirty (30) days in advance.
 The Nelson County Board of Education agrees to authorize the Nelson County Recreational Department the right of use of facilities/gyms to run said youth basketball program.
 This agreement includes use of supporting structures, unless otherwise specified: (i.e. bathrooms)
 For purposes of this agreement, the youth basketball program is designed as a program where all children who register under existing guidelines will be able to play on a team that matches their age and ability.
- 4. The Nelson County Board of Education shall provide annually a proof of liability insurance/certificate of insurance coverage with the Nelson Fiscal Court as an additional insured. The coverage should include, at a minimum, one million dollars with not less than a \$1,000 deductible per incident or claim.
- 5. The NCPRD will be in charge of hiring and paying person/persons to schedule referees for games for the youth basketball program.
- 6. Each school will pay \$40 per team to play in the youth basketball program. This money will help pay for the referee coordinator.
- 7. Money made during the season by said school will stay with that school. The exception shall be during any tournament when the school will pay the NCPR D/Nelson County Fiscal Court 25% of gate to help cover trophies and other expenses that may occur during the tournament.
- 8. Money made at gate will be use for the paying of officials that work said games. Remaining funds shall remain with host school.
- 9. Each school shall be responsible for providing uniforms and other required equipment for each basketball team.
- 10. All parents/students must sign and provide a copy to the NCPRD of a code of conduct and medical release prior to participating in the youth basketball program.

Schedules:

- 11. The NCPRD agrees to provide the Nelson County School Board and schools with written general schedule of games prior to the first game. Schedules shall list; at minimum, facility, dates and times. The Recreational Department will also provide updates or changes to the original schedule.
- 12. The NCPRD must coordinate with the schools/athletic directors when school facilities are available for use.

Facilities/Security:

- 13. Athletic Directors agree to monitor their gym being used to ensure that trash is cleaned up after use. These areas include any supporting structures.
- 14. The NCPRD will not allow alcoholic beverages and/or illegal drugs to be consumed on school property.
- 15. Each schools' athletic director will be responsible for purchase of supplies (i.e. concession supplies, basketball) for use during youth basketball season.
- 16. The athletic director of each school will be required to have background checks done for all coaches and assistant coaches involved in the youth basketball program prior to contact with the students/players. The NCPRD will keep these on file.
