#### **PROGRAM INFORMATION**

#### Please provide a brief description of the program for which you are seeking funding.

A preschool is required to serve students in a variety of areas-academic, social emotional, and physical. This grant serves in all three areas. How? Each season or month the gross motor area (from this equipment) will be themed. Students will utilize the preschool gymnasium to move through the maze gathering clues, items, materials laid out by our physical and/or occupational therapists, in October, for example the theme will be apples and pumpkins. Students will climb the ladder to gather apples, carry them down the climber to drop in a bucket labeled A. Pick pumpkins and scoot them to the barrel labeled with a P, etc. Children will have to learn to take turns, use physical skills, and academic skills to complete the round. This will continue all year, the maze can and will be altered for excitement as well as themed for the season. These skills cover KY State Standards and Developmental Standards in the state approved Teaching Strategies Gold.

Compelling need: K-readiness for our county has declined since 2013-2014 from 63.5% to 60.6%. Children in this grant program would otherwise go home after their 3 hour day. # How does this program address the United Way priority area(s) and the community problem?

This grant is asking for permanent equipment that will serve children for many years to come. Currently, it will serve 273 students; however, every 2-2.5 years we turn over to new students. This equipment will last a minimum of 10-15 years! It meets needs in all areas of health (moving your body-exercise), education (meets KY standards and Teaching Strategy Gold standards), and income because we serve Nelson County students/families in poverty. We are often their first experience with

public schools.

If preschool is able to meet academic, motor, and social deficiencies in early education while getting students ready for kindergarten we can eliminate the learning GAP in the 3rd grade. Preschool is a win-win for all parties!

\*Students enrolled in preschool who cannot afford transportation are funded by the district to attend ½ day childcare at no cost. (We currently have 11 students in this program.)

We work with FRYSC, the Nelson County Early Childhood Council, Fire Department outreach, Nelson County Schools Music Department, Participates with high school on Halloween to trick or treat, Nelson County Schools Child Care Department/Staff, Nelson County Health Department

# How is your program different from other programs offering similar services in your community?

- ❖ We enroll students all year as soon as they turn 3 years old.
- Our child care cost is drastically lower than our local competitors, and we employ student workers who are interested in a field of early childhood education.

#### How does/will your program identify itself as a United Way Community Partner?

The Village FRYSC and Nelson County Preschool will be proactive as United Way community partners by tagging emails, advertising partnerships on ClassDOJO, Facebook, Twitter, and through public announcements at the District School Board meeting. We would also be willing to film the students utilizing the equipment and share it with the United Way for their promotional videos.

Please explain any significant changes in number of individuals served/projected to be served. The previous grant served a small population at 3 schools on bully prevention. This grant serves the entire school population for years to come with the permanent equipment.

Please list your current (2018) objectives/outcomes <u>and</u> results from 2017 or 2018 YTD (ie. 75% of your clients will improve their job readiness skills. 2017 or 2018 YTD outcome result = 78%):

- 1. 5th grader referrals for bullying during the 2018-2019 will be reduced by 3% due to the prevention education efforts in the classroom from the material purchased/provided by United Way.
- 2. 20 Preschool and 12 elementary students were taught positive language techniques in June 2018 to use with peers which as they grow will eliminate bullying language. They were taught how to show acts of kindness towards one another through the Global Game Changer curriculum. Each student gained knowledge about how to fight apathy, supporting good, and making the world a better place. In addition, the GGC program enhanced academic outcomes and empowered students to find their inner superpower to make the world a better place and become engaged citizens.
- 3. 90% students who read "Wonder" by R.J. Palaccijo will be motivated to help spread acts of

- kindness at their school and community through participation in classroom activities relating to the contents of the book and workbook provided through United Way funds. In addition, reading performance level scores will increase 2% for the 2018-19 school year.
- 4. Bornlearning Program was offered in October-March, 2017 as a FRYSC sponsored event to fulfill the Families in Training Core FRYSC component. Two families, 7 individuals completed 6 sessions, one per month regarding education on child development. The most successful component of the program was the active networking between the parents.

Please provide any additional results, demographics and/or statistics on your program's successes and accomplishments.

The Preschool teacher indicated that her students benefited from the Global Game Changers program by learning how to better follow directions as well as demonstrating repeated acts of kindness in the classroom and not expecting anything in return. Students who were interviewed regarding the GGC program indicated gaining knowledge in the the twelve areas (elderly, poverty, veterans, environment, arts, rescue, hunger, bully prevention, general, animals, health, and education) taught by the leader. Also, the students expressed a desire to go out into the world and use their talents to ignite good!

What are the barriers/obstacles that you have experienced in terms of service delivery and/or to your client's success? While teaching classes during the summer I found it difficult to complete every lesson with those elementary students attending daycare on an inconsistent basis, therefore causing students to miss out on valuable lessons from the Global Game Changer's curriculum.

How are services/outcomes for this program currently measured (how do you know if you have achieved your desired results – ie. client surveys, monthly reports, client case notes, follow-up, etc.)? Outcomes were measured by the number of students (32) who graduated successfully through this program once they completed their Superpower Equation sheet describing how they would make a difference, each child was provided a Global Game Changer Official Superhero certificate. The children were also asked to give an oral presentation to the class of how they would make a difference in the world.

What are your projected objectives/outcomes for 2019 as they relate to United Way's priority area(s) that you chose (Education, Financial Stability and/or Health). Please provide at least three outcomes. Here are some suggestions; feel free to use/add your own projected outcomes:

**Education** (help children/youth to be successful in school)

- 1. Improve school Readiness.
  - 85 % of children will achieve developmental milestones.
  - 65% of children will be proficient on school readiness assessments.
- 2. Improve academic performance.
  - 25% of students will improve developmental growth.
  - 10% of students will improve school attendance.

## **Health** (promoting health)

- 1. Improve physical and/or mental health.
  - 75% of participants will improve their balance, steady gait, walking, hoping, increase strength and coordination.
  - 75% of participants will improve physical skills needed for kindergarten readiness.
  - 50% of participants will be encouraged to teach their parents about the skills learned with their family.

# 2019 Agency Agreement For

In order to share in the funds raised by the Tri-County Kentucky United Way, our program hereby agrees to:

- A. Cooperate and collaborate with other Agencies to prevent service duplication and promote effective services.
- B. Comply with all conditions and provisions governing supplemental fundraising activities as determined by the Tri-County Kentucky United Way Board of Directors in order to be eligible for **any** United Way funding:
  - a. Agency will <u>make every effort</u> to not conduct solicitations during the TCKY UW Campaign Drive, which is from September 1 through October 30. Agency events are acceptable if this is the best time of the year for your event.
  - b. There is to be no solicitation of a company's employees where payroll deduction campaigns are conducted and no payroll deduction campaigns on behalf of your agency.
- C. Keep complete and accurate records of accounts, which can be open to inspection by a

- representative of the Tri-County Kentucky United Way, if necessary.
- D. Be willing to submit to the United Way other reasonable information concerning finances, programs, etc. in accordance with the Board of Directors' or Allocation Committee's request.
- E. Ensure that the general public has the same access to services and goods provided by your agency that employees and volunteers of your agency have. No one shall have early access or special access to services and goods. Any special circumstance should be noted in writing and approved by the agency's board of directors and available for public inspection and knowledge upon request.
- F. Notify TCKY United Way, in writing, of any significant changes in the funded program or organizational structure that may affect the delivery of services prior to implementing the proposed changes. This includes, but is not limited to, a change in program philosophy, program model, client, delivery strategy, intended outcomes, indicators and results, etc. If a change does occur, TCKY United Way may ask for a revision to the funded application for further review by the Allocations Committee and Board of Directors.
- G. Submit a mid-year report (to be provided at a later date) of services at 6-months to the TCKY United Way (due July 15<sup>th</sup>, 2019).
- H. Have program information and the amount funded used in printed materials.

If approved for funding, payments will be mailed quarterly, starting on March 30, 2019 and subsequently on June 30, September 30, and December 30, 2019. Quarterly payments will be contingent upon program results and actual receivable unrestricted funds secured by the Tri-County Kentucky United Way.
