Commissioner Tackett,

In the 2018 Volleyball season, the volleyball coach of Graves County High School, located in Mayfield, Graves County Kentucky, *Brett Cariveau*, was awarded the Region One high school coach of the year. We, as concerned parents, wish to understand the selection and voting process of groups such as The Kentucky Volleyball Coaches Association (KVCA), which acts under the supervision of the Kentucky High School Athletic Association. Further and frankly, we wish to ask for a retraction of the Region One High School Coach of the Year award presented to Mr. Cariveau.

As you may or may not be aware, seven young women, who were members of this volleyball club, left the program due to Coach Cariveau's bullying techniques, including two seniors who will never, ever get this opportunity again. If there were only one or two players, this probably would be attributed to sour grapes or not being able to "handle a tough coach" and would not be a concern. However, we are speaking of seven individuals who claim or heard some form of verbal abuse. These seven young ladies expressed their concerns to their parents and friends over this type of "coaching."

Some of the preferred girls would claim no abuse but for the seven who were abused, targeted and bullied, there is a clear difference between difficult coaches and abusive coaches. There are similar instances of this technique in the school he previously coached for, Ballard County. One of these instances includes Mr.Cariveau "fat shaming" a young lad i.e. you are too big, get away from the buffet! Additionally, there are rumors, which are not confirmed as of the dictating of this letter, that Mr. Cariveau was terminated from a volleyball club, which he coached, because he was *too aggressive and bullied* the players. Regardless whether the last rumor is true or not, which can easily be determined, there is an air of divisiveness and bullying that permeates wherever Mr. Cariveau coaches.

As parents, we did not press the issue earlier or wish to publicize the issue through local media because we did not want to cast a shadow on the remaining girls' season nor create a retaliatory environment for the girls that were bullied. In keeping quiet, however, Mr. Cariveau was allowed to be elevated to the honor of Region One High School <u>Coach of the Year</u>.

Finally, it is hard to believe in the middle of the #Metoo movement that recognizes bullying and abuses committed against women, such bullying takes place in a public high school between a full grown male coach and teenage girls and this bully is then elevated to a <u>Coach of the Year</u> status for 2018!

Surely, this award must be based on more than a record and statistics. What about compassion? What about team building? What about character? A coach, must less a Region High School Coach of the Year, must personify all of these traits. Therefore, we, as parents, undersign our name to this letter formally requesting the withdrawal of the Region One High School Coach of the Year from Mr. Brett Cariveau.
