2019 Sports Officiating Summit — Training in Transition: Knowledge, Belief, Behavior

Program Abstract:

The NASO Sports Officiating Summit is designed for sports officials and those who administer officiating programs wanting to improve the overall safety and quality of sporting events by providing educational materials and training for new officials and developing the skills of experienced officials.

Now in its 37th year, the NASO Sports Officiating Summit is the only event that provides officials and officiating leaders resources and the opportunity to network and share their perspectives and experiences. Nearly 500 officiating leaders from across the country and Canada are expected to attend.

The 2019 Sports Officiating Summit will take place July 28-July 30 in Spokane, Wash. "Training in Transition: Knowledge, Belief, Behavior" is the main theme and will provide officiating leaders an information-driven educational program that will focus on issues and discussions related to the how, what and why of training programs for sports officials nationwide.

Proposal Summary:

Each year the National Association of Sports Officials (NASO) gathers officiating leaders from every level and sport from youth programs to professional leagues around the country for an annual meeting to discuss critical issues affecting officiating.

The NASO Sports Officiating Summit attracts representatives from all major professional leagues, collegiate, high school and youth levels because it is the only event of its kind, designed exclusively for sports officiating leaders.

In recent years many notable officiating leaders from professional, collegiate and high school sports have

attended or participated as speakers. These include: Carl Cheffers, Ron Foxcroft, Steve Javie, Clete Blakeman, Bill Carollo, Dale Scott, Bill LeMonnier, J.D. Collins, Sandra Serafini, Don Van Massenhoven, Monty McCutchen, Joan Powell, Larry Young, Matt McKendry, Debbie Williamson, Jerry Markbreit, Joe Crawford, Mike Pereira, June Courteau and many others.

These leaders, who impact officiating in their organizations, discuss real situations and discover real solutions that NASO puts into action and makes available for all sports officiating leaders upon adjournment.

The most recent example of how this action becomes a reality is the book Say Yes to Officiating: Recruit, Retain & Celebrate Sports Officials, which is the result of the 2018 NASO Sports Officiating Summit. These books will be distributed free of charge to governing bodies, conferences, leagues, officiating leaders and sports officials around the United States.

In addition to publications, each Summit attendee receives a resource manual that provides important related information for every session. This resource manual serves as an ongoing textbook and reference tool for leaders. Additionally, attendees gain valuable insight by interacting with officiating's most influential leaders through one-on-one and group meetings.

The 2019 NASO Sports Officiating Summit is vital not only to the officiating world, but also to the larger sports world. Better officiating leads to a more enjoyable experience for the participants and ultimately to the overall improvement of the game.

NASO cannot fully underwrite this crucial event. As a 501(c)(3) non-profit educational association supported almost entirely by individual member officials, NASO is not in a position to stage this event on its own — without support from organizations that have a stake in better officiating.

Summit Support Organizations:

In 2018, 90 organizations served as Summit Support Organizations (SSO). Their financial support enabled NASO to have the most important and far-reaching event since it began in 1980. An important measure of the success each year is the financial support provided by the key stakeholders within our industry.

Conducting such an event requires an enormous commitment of time and resources from a small staff. Facility space, audio-visual support and the staff time required to plan each session, develop support materials, coordinate, ship and more cannot be completely covered by a reasonable and fair registration fee. NASO needs assistance from organizations that benefit from this event.

Those that benefit most from this event are the governing bodies, the leagues and conferences, collegiate intramural programs, high schools, middle schools and recreation programs that administer sporting contests. They benefit because the officiating gets better and provides a better game experience for all participants.

B: FUNDING REQUEST

NASO is requesting an OPERATIONAL AND SUPPORT GRANT as shown on the accompanying Funding Request Sheet.

Project/Program Description:

NASO will host the 2019 Sports Officiating Summit – Training in Transition: Knowledge, Belief, Behavior – in Spokane, Wash., on July 28-July 30, 2019.

The Summit will begin with an opening session and keynote presenter on Sunday. Sessions that will focus on developing skills and perspectives that effective officials need to be successful today will follow this. In addition, the program will have sessions covering "Hot Topics" that are currently facing the officiating industry today.

NASO will also present its coveted NASO Gold Whistle Award at a sponsored gala event. This gala recognizes an individual who has provided outstanding service to the community of officiating. It is officiating's highest honor.

The host state of The Sports Officiating Summit has the opportunity to provide its members with a State Officiating Seminar on the Saturday prior to the opening of the Summit. This Saturday program offers a unique forum for the State High School Association to hold sport-specific meetings typically held across the state, in a single location. In recent years thousands of high school officials have participated in this event including more than 1,400 high school officials in New Orleans just last year. In addition, program support is available from NASO staff for content as well as keynote speakers.

NASO will also conduct its board of directors meeting and host the Officiating Development Alliance meeting. There will also be NFHS and state meetings, as well as other officiating organizations such as ArbiterSports on Sunday morning. All this activity is made possible through this important gathering of officiating leaders at one site discussing important issues.

C. NASO ORGANIZATIONAL INFORMATION

NASO was founded in Racine, Wis., in 1980 as a 501 (c) (3) non-profit educational association. 22,000+ sports officials worldwide are members of NASO. NASO provides education, training and benefits for sports officials working all sports and levels.

Over the past 36 years, NASO has also focused its efforts on advocacy and education for sports officials. Since 1987, NASO's legislative efforts have assisted in 21 states passing assault legislation, 17 states passing limited-liability laws protecting sports officials and 15

states passing independent contractor legislation – all designed to protect sports officials.

NASO has developed numerous publications addressing critical issues impacting officiating such as on-and-off-the-field accountability, evaluation systems, recruiting, retention and training. Through the Officiating Development Alliance, a blue-ribbon panel of officiating leaders, NASO has introduced to the officiating industry The Sports Officials Code of Conduct and A Covenant With Sports Officials. Each of these documents provides guidelines essential to professional conduct.

An 11-member board of directors oversees the strategic mission of NASO. The mission statement reads: NASO's mission is to serve as the leading source of officiating information, programs and services. In particular, NASO is committed to:

- Serve members by providing benefits and services.
- Improve officiating performance through educational materials.
- Advocate opportunities for officials and engage in programs to recruit and retain officials.
