

SCHEDULE OF STANDARD VARSITY OFFICIATING AND LICENSING FEES FOR 2019-2020

A regular season standard varsity per official is set by the Board of Control per the 1971 Federal Court Decree. An additional local mileage/travel allowance may be established by Regional Policy Board for regular season contests and is the only permitted adjustment to the standard fee

| Baseball | Standard fee is \$46 first contest for a two-person crew, \$41 each additional contest. If additional officials are assigned, the standard fee may be reduced by \$5 each. The total amount paid to baseball umpires in a given local policy board area may be no greater than \$10 more (per contest) than the amount paid to fast pitch umpires | District-\$65 per contest for a three-person or four-person crew Region-\$75 per contest for a four-person crew Semi-State-\$90 per contest for a four-person crew State-\$100 per contest for a four-person crew, State officials traveling greater than 100 miles one way would be paid an additional \$20 per official |
| Basketball | Standard fee is \$50 per contest - three (3)-person crew If due to an emergency approved by the Commission, a crew of two officials is used, the fee is \$75 per official. | District-\$85 per contest, three-person crew Region-\$110 per contest, three-person crew State-\$120 per contest, three-person crew, Officials traveling greater than 100 miles one way would be paid an additional \$20 per official |
| Field Hockey | Standard fee is \$56 per regular season contest | Region-\$65 per contest State-\$70 per contest, State officials traveling greater than 100 miles one way would be paid an additional \$20 per official |
| Football | Standard fee is \$65 per contest for a five-person crew. Standard fee is \$60 per contest for a seven-person crew (if mutually agreed by both schools) | \$100 /five-person crew, \$90 seven-person crew (first round), \$110 /five-person crew, \$100 seven-person crew (second round) \$110 /seven-person crew (third round) \$120 /seven-person crew (fourth round) \$145 /seven-person crew (State), State officials traveling greater than 100 miles one way would be paid an additional \$20 per official |
| Soccer | Standard fee is \$50 per contest - three (3)-person crew. If due to an emergency approved by the Commission, a crew of two officials is used, the fee is \$75 per contest | District-\$65 per contest Region-\$75 per contest Semi-State-\$95 per contest State-\$115 per contest, State officials traveling greater than 100 miles one way would be paid an additional \$20 per official |
| Softball | Standard fee is \$41 first contest for a two-person crew, \$36 each additional contest. If additional officials are assigned, the standard fee may be reduced by \$5 per official The total amount paid to baseball umpires in a given local policy board area may be no greater than \$10 more (per contest) than the amount paid to fast pitch umpires. | District-\$55 for three-person crew Region-\$65 for three-person crew Semi-State-\$80 per contest for a three-person crew State-\$90 for a three-person crew, State officials traveling greater than 100 miles one way would be paid an additional \$20 per official |
| Swimming | Standard fee is \$40 per meet. For invitational meets or those with four or more schools entered, the standard fee is \$60 | Region-\$75 per meet Region Swimming and Diving officials traveling greater than 100 miles one way would be paid an additional \$20 per official State-Licensed officials are utilized in a variety of roles and positions at the state meet with varying pay scales |
| Track and Field (and Cross Country) | Standard fee is \$30 per Cross Country race for the Meet Referee, who should be a licensed KHSAA official. Standard fee is \$45 per division for each of two licensed KHSAA officials for a standard school day or half-day (3 hours or less) weekend Track and Field Meet. For larger Track and Field meets that require longer than three hours, the standard fee is \$65 per each of the two licensed officials (Referee & Starter). | Region Cross Country-\$40 per race Region Track and Field-\$115 per classification (1 Region, boys and girls) Region Cross Country and Track and Field officials traveling greater than 100 miles one way would be paid an additional \$20 per official Cross Country and Track and Field State-Licensed officials are utilized in a variety of roles and positions at the state meet with varying pay scales |
| Volleyball | Standard fee is \$40 all regular season matches (including tournaments) 3 of 5 sets, or school option 2 of 3 sets | District-\$55 per match Region-\$65 per match State- \$85 per match, State officials traveling greater than 100 miles one way would be paid an additional \$20 per official |
| Wrestling | Standard fee is \$45 per standard dual match for one official, per match. For team based dual meet competition (tri, quad, etc.), the standard fee is \$40 per team round per official. Tournaments, \$25 per mat, per official, per hour, with a minimum standard fee of \$175 per official | Region-\$235 per single day tournament, \$335 per multiple day tournament , Region officials traveling greater than 100 miles one way would be paid an additional \$20 per official State-\$190 per day, State officials traveling greater than 100 miles one way would be paid an additional \$20 per official |
| Postseason Out of Region | Postseason- \$5 additional per official is added to the minimum standard base fee in Baseball, Basketball (District), Fast Pitch Softball, Field Hockey, Soccer and Volleyball if the assignment location is not in the normal service area (local association) of the official. | |
| Alternate Official | At the region level, the manager may request an alternate official if such duties are specified by rule codes. At the region and state level, an assigned alternate will be paid seventy (70) percent of the full on-field/court rate | |
| Board of Control Standard Varsity Fee Review Schedule | The Board will regularly review varsity contest fees in all sports on a defined schedule in the year prior to implementation of any change. In the years between, changes will only be considered if there is a change in playing rules or number of officials that necessitates emergency review. Non-varsity fees are to be addressed by the Regional Policy Boards only in the year following the review of varsity fees.. Considered during 2019/20 to be effective 2020/21 (and every four years thereafter) – Baseball, Softball, Field Hockey, Volleyball Considered during 2020/21 to be effective 2021/22 (and every four years thereafter) – Football and Soccer Considered during 2021/22 to be effective 2022/23 (and every four years thereafter) – Cross Country, Track and Swimming Considered during 2022/23 to be effective 2023/24 (and every four years thereafter) – Basketball and Wrestling | |
| Licensing Fees for 2019-2020 | Administrative Fee (paid once per official for background checks, the requested NFOA membership fee, ArbiterSports.com services, other fixed costs)- \$45 per year (reduced to \$35 for full-time college student, high school seniors and officials with 26 or more years service). An additional \$10 processing fee will be applied to all officials who pay for licensing fees with a check or cash. Per Sport Fee (paid per sport in which official is licensed)- \$25 (\$20 for full-time college student, \$0 for officials with 26 or more years service) | |
