Professional Learning (PL) Update:

April Professional Learning: NKCES supported a total of 189 professional learning opportunities focused on academics, culture and climate, leadership, and special education during the months of April, serving 1,655 educators.

NKCES Professional Learning Online Platform has proudly served more than 35,809+ educators since the inception of its first online learning Google site. NKCES online learning options have grown from one site with six trainings that debuted in the spring of 2020 to six sites with 125+ free online trainings as well as a variety of free online trainings and curated resources and support for educators, parents, caregivers, and substitute teachers.

Participants have taken the Working Genius assessment and are conducting personal reflection on how this impacts their work and personal lives. A book study on *The Eight Paradoxes of Great Leadership*, time for feedback on ideas and challenges, as well as requested agenda topics, have all made for an energetic and purposeful time together.

English Learners (EL) Program Update:

The EL Consultants, Heather Ralphes and Daniele Novak, will continue to provide student services through the first week of May. ACCESS scores arrive on May 6th, and after that date Heather and Daniele will share ACCESS scores with the districts and will collect input for students' PSPs.

NK Institute for Arts Education (NKIAE):



Mr. Joe Bertucci continued meetings with representatives from each district to share information about the new arts resources and professional learning available. Districts were asked to identify schools for participation in the AIM Program by April 11.

Mr. Bertucci collaborated with project evaluator Dr. Joan Ferrante to complete the first report to the U.S. Department of Education on our Assistance for Arts Education grant. The report was submitted on 04/15/22.

Mr. Bertucci and members of the NKIAE Steering Committee met with various partners to plan summer masterclasses for arts educators and our upcoming video series supporting arts education.

NKIAE celebrated the culmination of our 4-year Professional Development for Arts Educators Grant by organizing and funding student field trips to The Children's Theatre of Cincinnati and The Cincinnati Shakespeare Company and an event for teachers at Music Hall. Teachers from 11 districts attended the event.

CRRSA Update:

The CRRSA team provided professional learning opportunities on a trauma informed approach to teaching and continued to support districts in on-going professional learning such as math interventions, new teacher coaching and compassion resiliency. The team led the NKY MTSS Community of Practice with participants from across the region.

The Social Emotional Learning Specialists (SEL) have been working on a statewide collaborative project around the KyMTSS Tiers of SEL supports and the Learning Acceleration Specialists (LAS) across the state have been working together on the learning acceleration process.

The teachNKY collaborative website entered into its third month of publication, this month highlighting positive behaviors. Next month's topic will be focusing on adult SEL.

Special Education Update:

The NKCES DoSE Advisory Board met on April 18th. The NKCES DoSE Meeting was held on April 22nd. Topics of discussion included annual determinations, Indicator 8 Parent Involvement Survey, The KDE Office of Special Education and Early Learning (OSEEL) Retreat, etc.

Ms. Becky Nixon attended The KDE Office of Special Education and Early Learning (OSEEL) Retreat on April 11th and 12th. The Cooperative Special Education Directors along with the OSEEL Staff discussed OSEEL's North Star and their eight priority areas, 2022-2023 IDEA Proposals, reviewed regional and state special education data and discussed plus/delta around monitored activities.

Ms. Becky Nixon held a final meeting with districts involved in NKCES Visual Impairment Program. Discussions were held regarding services and program costs for the 2022-2023 school year.

Ms. Becky Nixon, Dr. Laura Clarke, Dr. Merissa Waddey and Ms. Emily Borchers attended the LRP Institute in Louisville, KY on April 25-27. They attended sessions specific to current legal findings in special education litigation.



The special education team conducted a series of compliance record reviews in districts across the region and provided compliance trainings specific to student participation in Alternate Assessment.

Dr. Laura Clarke and Dr. Merissa Waddey continued to provide ongoing support to the Regional Schools Program with coaching, observations, adapted materials, literacy support, and visual supports for behavior.

Dr. Merissa Waddey serves as Local Implementation Chair with the National Council for Exceptional Children and participated in a 2023 CEC Convention planning meeting on April 18th. Next year's National Convention will be held in Louisville.

Ms. Becky Nixon attended the Kentucky Council of Administrators for Special Education (KYCASE) planning meeting on April 26th. The KYCASE Executive Committee continued its planning for the KYCASE New DoSE Institute and the KYCASE Summer Institute which will be held in Lexington, KY on July 17-19th.

Drs. Laura Clarke and Merissa Waddey concluded the Alternatives for Exclusionary Discipline series for administrators on April 21st. The focus for the final session was on Alternative Discipline Menus and an analysis of disproportionate disciplinary data.

Dr. Laura Clarke participated in multiple planning meetings with the KY Council for Children with Behavior Disorders (CCBD) board to plan the 2022 Behavior Institute, which will be held on June 16-17 in Louisville, KY. Dr. Clarke, Dr. Merissa Waddey, and Ms. Misti Carr will be presenting sessions at the conference. Dr. Clarke worked with the KY CEC Board on planning for the national CEC Legislative Summit and the summer leadership meeting.

Mrs. Becky Nixon and Dr. Merissa Waddey kicked off our first SLP (Speech/Language Pathologist) PLN on March 30th. We look forward to growing this PLN for SLPs to have an opportunity for networking and a platform for sharing evidence based practices, resources and strategies.

Dr. Merissa Waddey collaborated with Michelle Klein of NKISP to provide training for administrators and SROs titled *SROs and Vaping Prevention* on April 20th. We had 18 SROs and administrators from across the Commonwealth.
