MEMORANDUM OF UNDERSTANDING

Between Light of Chance, Inc. and Hopkins County School District

I. PARTIES

This memorandum of agreement is by and between Light of Chance, Inc., a non-profit organization whose mission is to serve youth and the community through innovative arts and wellness programs, and Hopkins County Schools, a public school district located in Madisonville, KY.

II. PURPOSE OF THE UNDERSTANDING

This Memorandum of Understanding sets out the terms by which Light of Chance, Inc., its affiliate (Get Set Go Health & Wellness Company, LLC) and Hopkins County School District will continue to work together to implement Light of Chance's Breathe Youth Arts Program.

III. LIGHT OF CHANCE ROLES AND RESPONSIBILITIES

Light of Chance agrees to:

- 1) Implement its Breathe Youth Arts Program also referred as "Breathe Youth Arts Residency Program" at Hopkins County Day Treatment (HCDT) on a weekly basis which includes yoga, visual arts, music, and culinary arts classes.
- Provide individual and group therapy, peer support, and case management to HCDT students in partnership with Get Set Go Health & Wellness Company, LLC.
- 3) To provide individual, peer support, and case management to HCDT students once they return to their A1 school.
- 4) Not to provide a HCDT student therapeutic services if he/she is currently receiving the same service through another agency.
- 5) Receive parental or guardian consent prior to providing therapeutic services.
- 6) Provide staffing and program funding.
- 7) Provide background checks for employees and affiliates.
- 8) Report future criminal incidents, reports, or child abuse and neglect actions to direct partner.

IV. HOPKINS COUNTY SCHOOL DISTRICT ROLES AND RESPONSIBILITIES

Hopkins County School District agrees to:

- 1) Provide access to the school sites and space necessary for Light of Chance, Inc. and its affiliate to perform their work.
- Allow Light of Chance, Inc. and its affiliate to implement their "Breathe Youth Arts Residency Program" at HCDT on a weekly basis which includes yoga, visual arts, music, and culinary arts classes.
- Allow Light of Chance, Inc. to provide individual and group therapy, peer support, and case management to HCDT students in partnership with Get Set Go Health & Wellness Company, LLC.

4) Allow Light of Chance, Inc. and its affiliate to provide individual, peer support, and case management to HCDT students when they return to their A1 school.

V. CONFIDENTIALITY

Light of Chance and its affiliate agrees:

- 1) Not permit access to confidential FERPA-protected information to persons not authorized by the school district.
- 2) To maintain the confidentiality of the data.
- Not to reveal any individually identifiable information furnished, acquired, retrieved, or assembled by Light of Chance or others for any purpose other than statistical purposes specified in the school district survey, project, or proposed research.

VI. DURATION OF THE UNDERSTANDING

This understanding will remain in effect academic year-to-year and may be updated at any time through written agreement of each partner. Any party can terminate the agreement with 30 days notice.
