The Stronger Connections Grant (SCG) Program is intended to support evidence-based school safety and climate plans, along with other evidence-based strategies for creating safe, healthy, and supportive schools. Safe and welcoming schools depend on meaningful engagement between school and LEA leaders and students, parents, families, and community members, and strong relationships between students and adults.

The Strong Connections Grant is a one-time competitive grant for an award period of up to three years, funded through the Bipartisan Safer Communities Act (BSCA) of 2022 to help LEAs and schools establish safe, healthy, and supportive learning opportunities and environments.

Funds are available to support activities in PreK-12 schools and alternative education programs. Districts can submit one application.
