The bid shall be a lump sum for all properties of the Hopkins County School System, and shall be paid in twelve equal payments, upon receipt of an invoice each month.

The bid price shall include semi-annual operational tests and inspections. One hundred percent of all components of each system shall be tested and inspected at least once during the course of the year on a scheduled basis. The documentation will be filled in by a licensed inspector, with copies filed with the State Fire Marshall's office and to the office of the Assistant Superintendent for Facilities of the Hopkins County Board of Education.

It shall be the responsibility of the bidder to respond to an emergency report of fire alarm system trouble within forty-eight hours of notification. Any trouble in the system must be repaired within five working days of the time of notification. All travel and labor during normal business hours shall be covered for tests and emergency calls with the exception of "acts of God" damage.

The bid price shall cover the costs of parts that are components of the panel. A price chart shall be enclosed with the bid for all peripherals, such as pull stations, smoke detectors, bells, horns, and audio/visual units, with travel and labor to install them being covered in the bid price.
