V. Action Items

A. Recommendation to Receive a Report Regarding Board Policies to Implement Senate Bill 150; to Adopt Related Board Policies for First Reading; and to Receive for Review Related Administrative Procedures

Johnathan Lowe, executive administrator of policy and systems presented the Board with two versions of the policies and administrative procedures to implement Senate Bill 150, as well as a side-by-side comparison of the differences. Each Board member had an opportunity to comment and ask clarifying questions.

Mrs. Duncan stated that there are three areas that need to be revised for her to support either version of the proposed policies. She explained with the following remarks.

"... One area I think needs to be added to, is in the provision of single-use restrooms. We should say *monitored* single-use restrooms."

"A second change I'd like to make, when we have students who talk to us about abuse, we immediately are obligated to call Child Protective Services. When we have students who come to us and talk to us about mental health issues or sexual matters of some sort, I think at that point we should refer the student to our mental health practitioner in the building so that mental health person makes the determination of who else needs to be contacted, if anyone."

"And then on the pronouns, I think for our teachers' sake this issue is going to be very difficult because they don't always know what the preferred pronouns are When teachers have to talk with parents, we're expecting them to use preferred pronouns at school among other people but then when they have to have conversations with parents about their grades or whatever, then what happens to the preferred pronouns? That whole situation becomes very awkward for teachers. So, I think what we can require of teachers is that we address kids by their names. I think, whatever their name, whatever name that that student prefers to be addressed by, then that's what teachers can and should do and have done. Mr. Craig shared the following comments.

"I cannot think of a time when we had been tasked by the Legislature to implement policy that intentionally harms the students, and so we find ourselves in a very unique and precarious position and how to navigate this question. And if the law was settled, I'm not sure what we would do tonight, but I do not believe that the law is settled. I am an attorney, I am not this Board's attorney, but my view of the world is that transgender students in JCPS are protected by Title IX, are probably protected by the Equal Protection Claus of the United States Constitution and thus I'm not sure that Senate Bill 150 is binding until those questions are fully and finally resolved by either by the Sixth Circuit Court of Appeals or the United States Supreme Court."

"My vote tonight will be for Version 2, and Chair Porter, when we're done with our commentary here, I'll request that opportunity to make that motion unless somebody wants to make it first. And if it does not pass, it would also be my fervent belief that this board should not adopt Version 1 and should instead wait until we have had an opportunity to hear from the Department of Education in October as to what it intends to do."

Ms. McIntosh shared the following comments.

"There's no question that this is a horrendous bill. It was mean-spirited, the malintent is very clear that it is intended to further marginalize an already vulnerable group. It shouldn't have come to a point where our local Boards of Education are even having to wrestle with civil rights issues."

"My fear, my very deeply held fear is that the minute we stand up and say we are not going to follow the law then every step we take, whether we've broken the law or not, they're going to say we're breaking the law."

"... I would rather put the onus on them to prove it, prove that we're breaking the law by protecting children, prove that we're breaking the law by not allowing bullying whether it's from staff or from other people."

"I am trying to be very transparent and honest that Version 2 scares me for what they would use it for - to tear down our district, that they would come in and say, wait till next session, wait till you see what kind of bills we pass that are going to strip Jefferson County Board of Education of their Authority."

Dr. Kolb shared the following comments and questions.

"I won't repeat everything Board Member Craig said, but my stance is basically in lockstep with his in that, especially, I cannot vote for [Version] number 1 and I'm inclined to vote for number 2. The main reason I cannot go for number 1 ... is that there are still Clauses in it that basically erase people's identity."

"... Think about a child in school having to ask for special [bathroom] arrangements every time, it's just not something we can put into policy. I think that part is honestly a human rights violation."

"... If we pass something that is against the advice of Legal Counsel, what are the ramifications on that for potential legal action taken against the Board?"

"If the regulations that come out, hopefully on October 26th, go the way that we think they will go, would version 2 then - would we be able to stand behind that? Would Legal Counsel be able to stand behind that and have that not be against the advice of Counsel?"

"My order of preference is version 2, and then take no action tonight. Because there's two weeks until the start of school, we could continue to work on the policies. There's three weeks until August 15th which is the deadline the legislature set and even if we didn't hit those deadlines, we could still go without a policy until October 26th or soon after that."

Dr. Shull praised the speeches given by children and then had the following comment and question.

"I want to just acknowledge that I have full confidence in the professionals that are in our buildings day-in and day-out that, regardless of the policy, that they will do what is right ethically for every student and care for students as they have already."

"Is there gender-neutral bathrooms in every school?

Chair Porter made the following comments.

"... This board is here for children, this is public education and for those of us that have been through discrimination, we don't want our children discriminated. We want our children treated with love and respect. And yes, we will hear from Frankfort, it's not the first time, it's not the last time...."

"Public education is about educating our students and making them know that they are important to us. So, I'm not going to go through the various parts of it, but I would like to say that politics should work with public education instead of a distraction for the work that we must do for our students"

 VII.J. Recommendation for Approval of Competitive Negotiations, Bid Tabulations, Contract Renewals, and Amendments

Mrs. Duncan asked for more details regarding why Johnson was chosen for a weapons detection system. She also wanted clarification on pricing.

Dr. Kolb said the public deserves to know what the full range of consequences would be if the Board approves weapons detectors. He advised that there is no research on the technology being considered and it is impossible to demonstrate that weapons detectors are a wise and justifiable use of taxpayer money. He argued that they are quite the opposite, and they will hinder students' attempts to succeed. He went on to give multiple examples of how weapons detectors will seriously harm the educational environment, scaring children for no safety benefit, oppressing black and queer children, and likely increasing the amount of violence, crime, disruption, and disorder in schools. He concluded his remarks by saying, "I beg my colleagues to look at all the facts, to honor the commitment this board made to data and to equity, and to live up to the resolution we just passed in defense of our LGBTQ students. And with that, I would like to make a motion that we approve all of the bids in item VII.J. except for the bids for weapons detectors and that we reject all the bids in response to their request for proposals for weapons detectors."
