## What is TRUANCY and how do we help?

3 unexcused absences = Truant - First notice from schools
- No letters sent without direct contact from attendance
clerks - Individual meeting with DPP - Eligible for TDP Supports at school level through RtB

6 unexcused absences - Habitually Truant - Final Notice sent from DPP's Office - Mandatory home visit from DPP-TDP and/or Educational Neglect/Habitual Truancy Charges with CDW or County Attorney

### What is an excused/unexcused absence?

Excused - Unlimited Doctors Notes

Excused - Educational Enhancement Opportunities - 10

days max

Excused - Field Trips/Job Shadow/College Visits

Excused- Parent Notes - 6 for any reason including mental health

Excused - Building level admin can excuse absences on a case by case basis

Unexcused - anything not mentioned above

#### STUDENT ATTENDANCE MATTERS

There are an estimated 5–7.5 million students in the United States who are chronically absent from school.

Chronic absenteeism hurts students in a variety of ways as they progress through their school career, starting with kindergarten.

#### DEFINITIONS:

Chronic Absence - Missing 2 days each month, totaling 18 days, equals 10% of the school year

**Good Attendance** - Missing 9 days or less in a school year (5%)
