Change Order Description And Justification

Proposal 18R - This work is for adding additional trim to the ceiling to allow the new lights to

fit in the existing grid. The new lights that were available were slightly smaller in size and needed this additional trim. ADD \$8,146.

Proposal 19R - It was determined that the existing PA system in the existing building was nearing its end of life span. The contractor was able to provide a very economical cost for replacement as part of the new install. ADD \$28,423.

Proposal 20 - Supply power wasn't required to each individual VAV unit, rather to a centralized control panel. This resulted in fewer materials and labor required thus the credit to the owner. DEDUCT \$986.

Proposal 21R - Credit for three allowances which did not need to be utilized (undercutting, j-hooks above ceilings, and EMT conduit). DEDUCT \$43,700.

Proposal 18R - Lighting installation is complete and has a finished look.

Proposal 19R - Existing PA system was able to be upgraded in many areas at a very economical price point.


