

**RECIPIENT AGREEMENT FOR FUNDING FROM
THE OHIO VALLEY UNITED CHARITIES, INC.***

As a recipient for funding from the Ohio Valley United Charities, Inc., ("United Charities") the authorized representative of the charity agrees as indicated by the signature below to the following terms and conditions*:

1. That all funds which are received from the United Charities will be utilized for the projects and/or programs as outlined in the grant application filed with the United Charities, and are subject to audit by the representatives of the United Charities to confirm that they have been used in that manner;

2. That on or before December 31st, 2011, the recipient will file a report with the United Charities detailing: a.) the use of the funds received; b.) the level of success of the projects and or programs for which the monies were used; c.) **the number of persons which benefitted from the project or programs;** and, d.) whether the project or programs would have been possible without United Charities funding;

3. To include United Charities in the recipient's publications and promotional materials so that the public becomes aware that United Charities funded the project and/or program, and **to acknowledge that the recipient's project and/or program was made possible through funding from the United Charities in all printed materials distributed by the recipient and/or in fund-raising materials in regards to this project for which funding was sought;**

4. To furnish two (2) volunteers from the recipient, if requested, to explain the recipient's organization and activities to area employers and industries to assist United Charities in its fund-raising efforts, including its annual golf scramble; and,

5. The recipient understands that failure to follow this Agreement may result in the

recipient being ineligible for United Charities funding in the future.
