Mr. Sutherland asked Ms. Hoover about Mr. Watts expenses as reported on the administrator expense detail. After review, Ms. Hoover agreed there was an error and would make the necessary correction.

STUDENT LEARNING AND SUPPORT SERVICES

Superintendent's update:

Mr. Watts reported to the board that the high school exited CSI status. NIS and NHS are now is TSI status due to the African American sub-group.

Mr. Sutherland asked for an explanation of CSI and TSI. CSI stands for comprehensive support and improvement and TSI stands for targeted support and improvement.

Beginning with the 2022-23 school year, and every three years thereafter, the Kentucky Department of Education will identify Comprehensive Support and Improvement schools (CSI). This identification is a required element of Every Student Succeeds Act of 2015 (ESSSA). As local education agencies work to improve student outcomes by addressing the student-, teacher- and school-level factors that drive achievement gains, the Kentucky Department of Education seeks to guide and support districts through the school improvement process.

Once schools have received notification of their CSI identification, they must work with local stakeholders to develop and implement a turnaround plan that summarizes the steps the school will take to improve learning conditions. ESSA provides the opportunity, flexibility and responsibility for state and local education agencies to select appropriate, relevant interventions with the strongest evidence base possible to implement in schools needing improving. By law, these plans must be informed by all the indicators in the state's accountability system, include evidenced-based interventions, be based on a school-level needs assessment and identify resource inequities that must be addressed.

Upon identification, TSI schools must revise their Comprehensive School Improvement Plan (CSIP) to include components of turnaround leadership development and support, the identification of critical resource inequities, evidence-based interventions, and any additional actions that address the causes of consistently underperforming subgroups of students. Revised CSIPs must be approved by the local board of education. The district must monitor and provide support to TSI schools.


Ms. Payne, Chief Academic Officer, presented Spring 2023 KSA data. Her report covered:

- Federal Classification TSI and CSI I and CSI II
- State indicators in the accountability system
- Overall designations: Blue, Green, Yellow, Orange, Red ratings will be reported using a color rating system to communicate performance of school with red being lowest and blue being highest.
- Accountability profile and indicator scores and ratings.
 - NPS and NIS overall performance Orange TSI African American
 - NHS (MS) overall performance Red TSI African American
 - NHS (HS) overall performance Orange
- ACT results:- all students average composite score 16.7
 - African American 14.9
 - Hispanic or Latino 15.4

- o White 17.4
- o EL suppressed
- o Free/Reduced 15.9
- Disability with IEP suppressed
- Graduation rate 2021, 94.9% 2022, 91% 2023, 92.2%


The principals presented iReady and MAP data for reading and math comparing 2022 and 2023 reading and math scores. The results of these two assessments produced very similar data results.





Data systems in place include:

- Wonders and Math in Focus for grades K-6
- Envisions and MyPerspectives for grades 7-12
- Assessment analysis (by student; by standard)
- Identification of Tier II and Tier III in reading and math for grades K-8
- Triangulation of all data (curriculum assessments, MAP, iReady, Aimsweb)

Mr. Sutherland asked how the board can help especially with those 7th and 8th grade students 3 grade levels behind. Ms. Payne reassured the board there is a plan in place for teachers to work with these students to get them caught up using programs already in place.

Mr. Curl asked about the early warning tab. Ms. Payne explained that KDE developed the Persistence to Graduation Tool and has also collaborated with Infinite Campus to develop an Early Warning System, which is a complex data tool using student level data. The Early Warning features allow district and school personnel to better understand what is contributing to each student's risk of dropping out, and most importantly, what areas of intervention might yield the greatest impact on their journey towards graduation.

Ms. Malone asked about LacyAnn Howard being awarded the KY Council of Exceptional Children's Yes I Can award. This award recognizes six students from across the state who excel in one of the following areas: academics, arts, transition, technology, school & community activities, and self-advocacy. LacyAnn will be recognized for her accomplishments in art and receive the award at the Exception Children's Conference in Louisville on November 20th.

Joe Bramlage, NHS Special Education chair will represent Newport and serve on the NKY Transition team. He will attend trainings on topics designed to ensure student's with exceptional needs are successful in achieving their post-secondary goals.
