He concluded by thanking staff for their hard work and dedication.

X. Information Items

A. Update on Transportation

Dr. Pollio introduced this item and Dr. Rob Fulk, Interim Chief Operations Officer, presented the update. Each Board member had an opportunity to comment and ask questions.

Dr. Kolb said, "I don't feel like it's responsible to have more routes than we have drivers available on any given day." He stated that the Board must be willing to raise revenue to increase bus driver pay to attract more drivers.

Ms. McIntosh confirmed that there would not be any transportation solutions proposed for the current school year. She then asked, "How is the District supporting the staff that continues to have to stay after school one, two, or three hours after the end of their contract time?" She expressed concern about possible resignations among administrators and folks who are pulling 10 to 12-hour days every single day. She asked if the administration staff could receive extra pay stipends. She expressed concern about student behavior on buses and requested data regarding the impact of the clerks at the compounds. She concluded by questioning Title I violations with student confidentiality if transportation revisions only provide buses for free/reduced lunch students.

Mr. Craig stated that he submitted his questions before the meeting. He said that the Board must ensure they have the best superintendent, and that he hires the best staff to present a recommendation to overcome the Transportation challenges.

Mrs. Duncan expressed concern with students who are getting home late in the evening. She said she preferred to have only two start times. She suggested they provide a stipend for families to self-transport. She questioned what time the last bus leaves for the day. She asked how many non-bus driver staff members are using their CDL to help pick up routes.
