HARMFUL TO MINORS COMPLAINT RESOLUTION FORM

The book that is harmful to minors is called "Endlessly Ever After." In this book and throughout each page, the reader can pick from two different scenarios on whether they want to go to one adventure or another. In the book they have a character named Rosie, who is Red Riding Hood. When you read page 56 of the book it states, you (Rosie) head off through the trees again. You track the shouts of rage and find them coming from a kid, a boy about your age. As you see from this statement that Rosie or Red Riding Hood is a kid or a little girl. Now when you read page 42 it then states, you (Rosie) wander up a winding stair, you scamper past a throne, until you find a tiny room, where sleeping like a stone. There are two choices for a child to pick from and in this scenario, it says, Now what Rosie? Are you really going to kiss some strange sleeping women in a frozen castle covered with roses? Seriously?

Option 1- "Yes, life is an adventure!" Turn to page 48.

Option 2- "No, ew! Of course not. Kissing is for teenagers", Turn to page 36.

So, if the child turns to page 48 it then states, "Oh my gosh, you did it! You kissed the princess fair, who softly stirs and yawns at you through endless yards of hair." So, when we look at this scenario in the story, we can see that if the child picks yes then it allows for a child (Red Riding Hood) to kiss a woman (Sleeping Beauty). If the child says no, it declares that kissing is for teenagers. So, you can see that when a child reads this content it is approving for a little girl or even a teenager, which is also a minor, to kiss a grown woman who is a stranger. In the original sleeping beauty, a grown man kissed a grown woman. This book implies that it's ok for a child to kiss a grown adult and a stranger as well. This is suggesting that Pedophilia is acceptable. This book should not be allowed for our children to read and allow for idea to be acceptable. When my daughter brought home this book from the library, we read it not knowing anything about the book and the content that was within the book. My daughter was very confused when she read this part of the story and as a mom, I had to have a conversation with her about this and how this is wrong. I am aware that other students could be checking this book out of the school library and reading it at school or home without their

parents or guardians knowing the content that is in the book. All parents and guardians have the right to know what their children are reading and should be able to approve the book before it's checked out of the library. In this case, due to the nature of this book it should not be allowed in the school library since it is promoting inappropriate material.

Appeal to the Boone County School Board

I am making an appeal to the Boone County School Board on 1/4/24 per the "Harmful to Minors" Complaint Resolution Process Form. The first step I was told to take was to go through the Reconsideration Committee. After a month I was made aware of their decision to keep the book in circulation at the school. I then proceeded to talk with Jenny Watson at the Boone County School Dept who made me aware of the Harmful to Minors Complaint Resolution Process Form to fill out to escalate to the principal Mrs. Stephanie Stambaugh at Longbranch Elementary. After I submitted the form and complaint, Mrs. Stambaugh got back to me with her decision two weeks later. She had also decided that the book was ok to stay in circulation. I then scheduled an appointment to meet with Mrs. Stambaugh and the school counselor Mrs. Ballou. Per our sit-down conversation, Mrs. Stambaugh stated that she made her decision on the harmful to minors complaint resolution form only on the basis to back up and stand with her reconsideration committee decision. This was not a separate decision that she made based upon her own research but that she wanted to support the committee.

I am now escalating and appealing the principal's determination to the board based upon the harmful aspect of this book. Please see attached form to advise on what is inappropriate in the book Endless Ever After that I sent to Mrs. Stambaugh per the harmful to minors complaint resolution form. As you can see from the form, I submitted that this book violates Kentucky's statutes on Sexual Exploitation of Minors. Pursuant to KRS 531.010, 531.080 and 531.310 and 531.370 this book should not be distributed in Longbranch Elementary. This book is in violation of promoting sexual conduct by a minor by acts of homosexuality and lesbianism. This is promotion of illegal material to minors. I have also been in contact with our state representative regarding this matter and we are working together on this issue. This is not an issue of opinion but a matter of law and upholding the law. If my daughter hadn't brought this book home, then I would not have known what was in the book. Many other children at Longbranch Elementary are currently reading this book without the knowledge or consent of their parents. We as parents and taxpayers have a right to know what our children are reading and what is in the school libraries. I asked the school board members and superintendent to review all content and uphold the law for minors and protect our children and the rights of the parents.

531.300 Definitions for KRS 531.080 and 531.310 to 531.370.

As used in KRS 531.080 and 531.310 to 531.370:

- (1) "Distribute" means to transfer possession of, whether with or without consideration;
- (2) "Matter" means any book, magazine, newspaper, or other printed or written material or any picture, drawing, photograph, motion picture, live image transmitted over the Internet or other electronic network, or other pictorial representation or any statue or other figure, or any recording transcription or mechanical, chemical or electrical reproduction or any other articles, equipment, machines, or materials;
- (3) "Obscene" means the predominate appeal of the matter taken as a whole is to a prurient interest in sexual conduct involving minors;
- (4) "Sexual conduct by a minor" means:
 - (a) Acts of masturbation, homosexuality, lesbianism, bestiality, sexual intercourse, or deviant sexual intercourse, actual or simulated;
 - (b) Physical contact with, or willful or intentional exhibition of the genitals;
 - (c) Flagellation or excretion for the purpose of sexual stimulation or gratification; or
 - (d) The exposure, in an obscene manner, of the unclothed or apparently unclothed human male or female genitals, pubic area or buttocks, or the female breast, whether or not subsequently obscured by a mark placed thereon, or otherwise altered, in any resulting motion picture, photograph or other visual representation, exclusive of exposure portrayed in matter of a private, family nature not intended for distribution outside the family;
- (5) "Performance" means any play, motion picture, photograph or dance. Performance also means any other visual representation exhibited before an audience;
- (6) "Sexual performance" means any performance or part thereof which includes sexual conduct by a minor; and
- (7) "Promote" means to prepare, publish, print, procure or manufacture, or to offer or agree to do the same.

531.020 Distribution of obscene matter.

- (1) A person is guilty of distribution of obscene matter when, having knowledge of its content and character, he:
 - (a) Sends or causes to be sent into this state for sale or distribution; or
 - (b) Brings or causes to be brought into this state for sale or distribution; or
 - (c) In this state, he:
 1. Prepares, or
 2. Publishes, or
 3. Prints, or
 4. Exhibits, or
 5. Distributes, or
 6. Offers to distribute, or
 7. Has in his possession with intent to distribute, exhibit or offer to distribute,any obscene matter.
- (2) Distribution of obscene matter is a Class B misdemeanor unless the defendant has in his possession more than one unit of material coming within the provisions of this chapter, in which case it shall be a Class A misdemeanor.

531.030 Distribution of obscene matter to minors.

(1) A person is guilty of distribution of obscene material to minors when, knowing a person to be a minor, or having possession of such facts that he should reasonably know that such person is a minor, and with knowledge of the content and character of the material, he knowingly:

- (a) Sends or causes to be sent; or
 - (b) Exhibits; or
 - (c) Distributes, or offers to distribute,
obscene material to a minor.
- (2) Distribution of obscene materials to minors is a Class A misdemeanor unless the defendant has previously been convicted of violation of this section or of KRS 531.020, in which case it shall be a Class D felony.

531.010 Definitions.

As used in this chapter:

- (1) "Distribute" means to transfer possession of, whether with or without consideration.
- (2) "Matter" means any book, magazine, newspaper, or other printed or written material or any picture, drawing, photograph, motion picture, live image transmitted over the Internet or other electronic network, or other pictorial representation or any statue or other figure, or any recording transcription or mechanical, chemical or electrical reproduction or any other articles, equipment, machines, or materials.
- (3) "Obscene" means:
 - (a) To the average person, applying contemporary community standards, the predominant appeal of the matter, taken as a whole, is to prurient interest in sexual conduct; and
 - (b) The matter depicts or describes the sexual conduct in a patently offensive way; and
 - (c) The matter, taken as a whole, lacks serious literary, artistic, political, or scientific value.
- (4) "Private erotic matter" means an obscene visual image, including a photograph, film, video recording, or digital reproduction, of an identifiable person, depicting sexual conduct or the exposure of uncovered human genitals, buttocks, or nipple of the female breast. A person may be identifiable from the image itself or from information distributed in connection with the visual image.
- (5) "Sexual conduct" means acts of masturbation, homosexuality, lesbianism, bestiality, sexual intercourse, or deviant sexual intercourse; or physical contact with the genitals, flagellation, or excretion for the purpose of sexual stimulation or gratification.

Dear Ms. Yates,

I received the Harmful to Minors Complaint you provided to the school on December 1, 2023. Pursuant to KRS 158.192, Board Policy 8.23, and 8.23 AP .21, I have conducted an investigation into your Complaint relating to the book, titled "Endlessly Ever After" by Laurel Snyder and Dan Santat ("the Book"). The purpose of this letter is to overview the findings of my investigation and advise on my conclusions as to whether this book is "Harmful to Minors" as defined by law and policy.

I. Background

On October 29, 2023, you emailed me asking for a time to meet and discuss a library book that your daughter checked out from the LBES library which you felt contained "inappropriate content." (See Attachment 1) In response, I provided you with a copy of the LBES Reconsideration Policy. (See Attachment 2) Construing your email to be a formal request for reconsideration of the Book's inclusion in the LBES library, I advised you that I would begin the formal Reconsideration process.

The Book in question is a choose-your-path picture book incorporating several popular children's stories and fairytales. (See Attachment 3) Throughout the book there are references to Little Red Riding Hood; Snow White and the Seven Dwarfs; Mother Goose (and her son Jack); Sleeping Beauty; and Hansel and Gretel. The Book is less than 100 pages and recommended for readers ages 5 - 9, grades K - 3. In your emails to me, you indicated concern that "In one of the scenarios their (sic) is a choice for an 8 year old Red Riding Hood little girl to kiss Sleeping Beauty on the mouth." I relayed this information to the LBES SBDM as a part of your Reconsideration request.

The LBES SBDM Council took up the Reconsideration request at its November 14, 2023 meeting. (See Attachment 4) After careful consideration, the LBES SBDM Reconsideration Committee denied the reconsideration request and voted to keep the Book in circulation. (See Attachment 5) The Committee specifically reviewed the portion of the Book with which you have expressed concern. The first option reads:



You wander up a winding stair; you scamper past a throne,
until you find a tiny room, where sleeping like a stone,

a gentle maiden waits for you. Her eyes are sweetly shut.
Her lips are waiting for a kiss. And so you bend and . . . WHAT?

Now what, Rosie? Are you really going to kiss some strange sleeping woman
in a frozen castle covered with roses? Seriously?

Yes, life is an adventure! Turn to page 48
No, ew! Of course not. Kissing's for teenagers. Turn to page 36

THE END



Relying primarily on the Kentucky Bluegrass Award Master List and Committee's objectives to provide students with choices in their reading selections, the Committee concluded that the Book's content was appropriate. In its letter to you, the Committee explained that the Book "clearly states that kissing is for teenagers and ... is not oversexualized in any way just as it is not in the original version of Sleeping Beauty."

I advised you of the Council's decision on November 16, 2023. (See Attachment 6) In response, you advised that you disagreed with the Committee's decision "because there is intent to normalize a girl kissing another girl for sexual purposes" and that it "does not matter if it's over sexualized or not." In my reply, I copied Jenny Watson, the Assistant Superintendent for Learning Support Services, to provide you with additional information.

In your emails to Dr. Watson, she explained that Kentucky law and Board Policy provides school councils with the authority to oversee the content of the respective school library. And, per

Board Policy, a Reconsideration request cannot be appealed to the Board of Education. However, in your email exchanges, you indicated to Dr. Watson your belief that the Book “promoted gross sexual behavior for children” and includes “inappropriate sexual content that could be harmful in teaching children.” Because of the allegation that the content was not just objectionable, but actually *harmful*, Dr. Watson provided you with a copy with the Harmful to Minors Complaint and accompanying Board Policy. (See Attachment 7)

I received a copy of your Complaint on December 1, 2023. (See Attachment 8) As a part of my investigation and decision-making process, I have reviewed your Complaint, a complete copy of the Book, the Reconsideration Committee’s Decision, and emails exchanged between you, myself, and Dr. Watson.

II. Harmful to Minors Decision

Pursuant to KRS 158.192(a), “harmful to minors” means materials, programs, or events that:

“(a) Contain the exposure, in an obscene manner, of the unclothed or apparently unclothed human male or female genitals, pubic area, or buttocks or the female breast, or visual depictions of sexual acts or simulations of sexual acts, or explicit written descriptions of sexual acts;

(b) Taken as a whole, appeal to the prurient interest in sex; or

(c) Are patently offensive to prevailing standards regarding what is suitable for minors.”

After review of the relevant materials, the subject matter contained within this story does not meet criteria under the statutory definitions for material that could be considered harmful to minors.

First, it is my assessment that “Endlessly Ever After” does not contain or expose the human body, nor does it give any visual depictions of a sexual act or explicit written descriptions of sexual acts. The act of kissing is not inherently sexual and therefore I do not believe the material falls under the definition provided in KRS 158.192(a).

Second, the Book taken as a whole does not appeal to the prurient interest in sex. KRS 158.192(b). “Material appeals to the prurient interest, for instance, only if it is in some sense erotic.” *Ashcroft v. ACLU*, 535 U.S. 564, 579 (2002); *Cf. Erznoznik v. Jacksonville*, 422 U.S. 205, 213, n. 10 (1975). Sleeping Beauty, along with the other fairy tales referenced in the Book, are widely accepted as children’s tales and are not regarded as sexual in any way and are certainly not



“erotic.” The presentation of the Sleeping Beauty narrative contained in this Book is no different. In fact, this Book even provides an option for the reader to say he or she is too young for kissing, which directly cuts against any argument that the Book is overtly appealing “to the prurient interest of sex.”

Finally, the material, subject matter, characters, and themes contained in the Book are not patently offensive. *See* KRS 158.192(c). The “prevailing standards regarding what is suitable for minors” is not defined by law nor is it explained in commentary to the statute. So, to determine these standards, I look to other sources in the community. To that end, I think it is important to acknowledge that the LBES SBDM – which is primarily composed of parents in the LBES community – voted to keep this Book in circulation, finding it appropriate for children (their own included). While I acknowledge your concern related to the age of the main character (8 years old), I do not believe this book is inappropriate since the themes contained in the book are based on a well-known fairytale.

It is important to note that, if it is determined that this kiss between “Rosie” and “Sleeping Beauty” is deemed harmful to minors, every book in the library that in any way references or depicts a kiss between characters would likewise need to be removed from circulation. This could amount to *hundreds* of books being removed from the LBES library. Due to First Amendment considerations, and keeping with the LBES policy, I am unable to consider the context of this kiss (between Rosie and Sleeping Beauty) to differentiate why this kiss would be considered “patently offensive to prevailing standards” while another kiss would not be considered as such. Kissing is not offensive, nor is it sexual. As such, I do not find that the Sleeping Beauty storyline in the book “Endlessly Ever After” is harmful to minors as defined by law or board policy.

III. Conclusion

This letter serves as notice that pursuant to KRS 158.192 (2)(d)-(e) and the applicable Board policies, I have determined that the book “Endlessly Ever After” is not harmful to minors and the book shall remain available for check out at the school library. However, as discussed in our previous conversations, I have flagged the Book in your child’s library account so that your child will be unable to check out the Book in the future.

If you have any questions or would like to meet and discuss my decision, do not hesitate to reach out so we can schedule a time most convenient for you. Here at LBES, we want all of our student to have access to programs and materials that will enable them to ACHIEVE beyond expectation, LEAD with great character, and positively IMPACT our community. And importantly, we want students and their parents to feel safe and comfortable with the learning environment we have created. Although the book will stay in the library, I am happy to discuss additional ways we can work with you to facilitate the best learning environment for your child.

POLICY TOPIC DESCRIPTION

Reconsideration Policy

POLICY STATEMENT

The media centers of Boone County Schools fully support the First Amendment of the Bill of Rights, the American Library Association's Library Bill of Rights, and the concept of intellectual freedom. Our school media centers do not support any one idea, philosophy, or perspective. Using the terms described in each school's Selection/Collection Development Procedures, every effort is made to include items in the library's collection that meet the needs of the school and students. Every individual has the right to seek information from all points of view without restriction. The responsibility for the individual choice of reading materials by minors rests with the parent or legal guardian.

We have established procedures for the reconsideration of materials in the library collection. We welcome our school community to discuss with us our selection procedures when a question arises concerning resources in the school media center. All inquiries about library materials or challenges to library materials will be recorded by the school principal for reference purposes.

Individuals wishing to formally challenge materials for reconsideration must read/view the material in its entirety before following the steps below.

STEPS FOR RECONSIDERATION OF SCHOOL OR CLASSROOM LIBRARY COLLECTION

1. A Request for Reconsideration of Library Collections Form must be requested from the school principal by a Boone County resident who provides proof of residency AND has a student currently enrolled at Longbranch Elementary. The challenged material will remain in circulation until the process is complete.
2. Upon the completion of the Request for Reconsideration of Library Collections Form is complete, the principal will inform the Assistant Superintendents of Learning Support Services of the request for formal reconsideration.
3. The school principal will form a reconsideration committee. This committee shall consist of: an administrator, two (2) teachers from the appropriate grade levels, and two (2) objective community members/parents.
4. The committee will review the Reconsideration Form and seek input from the Library Media Specialist as to how the material supports the library collection based on the selection procedure considerations.

5. A meeting of the committee will be held within 30 working days after the form is submitted. The committee will read the Request for Reconsideration of Library Collection, as well as review the material(s) in question.
6. Committee members form an opinion on the material(s) as a whole and reach a consensus decision to retain or remove the material(s). In the case that a consensus cannot be reached, a vote will be taken and majority rules.
7. The school principal will complete a report of the committee procedures and decision. This will be submitted to the Assistant Superintendents of Learning Support Services and the complainant.
8. Once a material has been reviewed, the decision of the committee will stand for one calendar year regardless of other Reconsideration Requests made for that material. A new committee will not be formed for subsequent Reconsideration Requests.

Reconsideration Committee Members Responsibilities:

- Based on the First Amendment, the freedom to read is essential to our democracy. Allow these principles and the [freedom to read](#) to guide your decision rather than in defense of individual materials.
- Read or view all materials referred to you including the full text of the material in question, available, reviews, and notices of awards, if applicable. Consult standard evaluation aides and the Boone County Selection policy.
- Review the Boone County Schools Library Mission Statement, materials selection, and reconsideration policies, and professional guides, such as the [Intellectual Freedom Manual](#).
- Passages or parts of the work in question should not be pulled out of context. The values and faults should be weighed against each other and the opinions based on the materials as a whole.
- While it may be prudent to state what area/role a committee member represents in the makeup of the committee (i.e., teacher, librarian, community members, administration, parent, etc.), the personal identification of each member should remain anonymous to protect the objectivity of the deliberation.
- The reconsideration committee meeting may be closed depending on state law and local practice. While public comments may be useful, these comments should be directed to the school principal.
- The committee's recommendation is to be an objective evaluation of the material within the scope of a library's selection policy.
- The committee's report, presenting both majority and minority opinions, should be presented to the school principal as directed in the reconsideration process, with a recommendation to retain the material in its original location or to remove the material. The report may differ depending on the type of resource that is being challenged, such as library material, display, reading list, etc.
- The committee will communicate its decision to the school principal, who then communicates the decision to the person who made the challenge as well as to the Assistant Superintendents of Learning Support Services.

This interactive text engages readers in a unique literary experience, where their actions have consequences, sometimes leading to positive outcomes and at other times to more challenging and thought-provoking consequences. 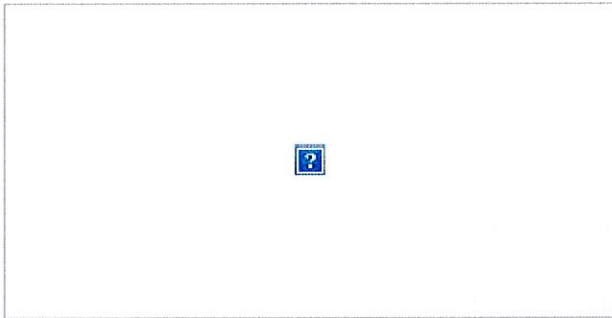

HARMFUL TO MINORS COMPLAINT RESOLUTION FORM

The book that is harmful to minors is called "Endlessly Ever After." In this book and throughout each page, the reader can pick from two different scenarios on whether they want to go to one adventure or another. In the book they have a character named Rosie, who is Red Riding Hood. When you read page 56 of the book it states, you (Rosie) head off through the trees again. You track the shouts of rage and find them coming from a kid, a boy about your age. As you see from this statement that Rosie or Red Riding Hood is a kid or a little girl. Now when you read page 42 it then states, you (Rosie) wander up a winding stair, you scamper past a throne, until you find a tiny room, where sleeping like a stone. There are two choices for a child to pick from and in this scenario, it says, Now what Rosie? Are you really going to kiss some strange sleeping women in a frozen castle covered with roses? Seriously?

Option 1- "Yes, life is an adventure!" Turn to page 48.

Option 2- "No, ew! Of course not. Kissing is for teenagers", Turn to page 36.

So, if the child turns to page 48 it then states, "Oh my gosh, you did it! You kissed the princess fair, who softly stirs and yawns at you through endless yards of hair." So, when we look at this scenario in the story, we can see that if the child picks yes then it allows for a child (Red Riding Hood) to kiss a woman (Sleeping Beauty). If the child says no, it declares that kissing is for teenagers. So, you can see that when a child reads this content it is approving for a little girl or even a teenager, which is also a minor, to kiss a grown woman who is a stranger. In the original sleeping beauty, a grown man kissed a grown woman. This book implies that it's ok for a child to kiss a grown adult and a stranger as well. This is suggesting that Pedophilia is acceptable. This book should not be allowed for our children to read and allow for idea to be acceptable. When my daughter brought home this book from the library, we read it not knowing anything about the book and the content that was within the book. My daughter was very confused when she read this part of the story and as a mom, I had to have a conversation with her about this and how this is wrong. I am aware that other students could be checking this book out of the school library and reading it at school or home without their

parents or guardians knowing the content that is in the book. All parents and guardians have the right to know what their children are reading and should be able to approve the book before it's checked out of the library.
