

### Federal Programs

#### Title I, Part A

Newport Independent has mailed Declaration of Participation invitations to private schools. Private schools that wish to participate in Federal Programs have until March 29, 2024 to return this paperwork indicating their intent. These schools include: Holy Trinity, Holy Cross, Covington Catholic, St. Anthony, Calvary Christian, St. Catherine, St. Joe, Newport Central Catholic, St. Therese, and Notre Dame.

#### Title II and Title IV

An overview of Title II and Title IV has been provided to Cabinet members and School Administration. Newport Independent has traditionally rolled all Title II and Title IV funding to Title I.

#### Title III and English Learners Program

English Learners Extract report has been prepared for the state data pull. Newport Independent currently has 180 students for whom English is a second language. Home languages include Spanish, Arabic, Swahili, Gujarati, Japanese, Mai Mai, Rundi, and Somali.

### Calendar

In the spring each school district must amend the school calendar to reflect any changes that have occurred. After Board approval, the Amended Calendar is then submitted to the Kentucky Department of Education for approval. Upon NISD approval, communication and an updated

- June 4, 2024 Closing Day for all 186 day staff that have not completed contract time
