KHSAA RULES AND REGULATIONS Governing Tennis Tournaments

(Adopted by the Board of Control) (Case situations refer to rulings and interpretations used to administer these provisions which can be found in the next section of the Handbook)

I) Assignment of Schools to Regions

The Kentucky High School Athletic Association shall sponsor postseason competition in tennis for boys and girls, provided that fifteen (15) percent of the member schools declare intentions to participate in said competition. Member schools desiring to participate in KHSAA sponsored postseason competition shall notify the Association office prior to March 1. The Commissioner shall divide the state into geographic sections with the approval of the Board of Control. Newly added or deleted programs will be handled on a case by case basis by the Commissioner's office.

As of August 1, 2010, the alignment in tennis is as follows -

II) Dates and Sites for Tournaments

The Commissioner with the approval of the Board of Control shall determine the dates and sites of the regional, section (team only) and state tournaments. All tournaments will be held within the dates indicated on the Memorandum Calendar unless otherwise approved in writing by the Commissioner.

Schools interested in hosting a regional tournament shall submit their request in writing prior to October 1 of the tournament year. The applicant shall supply information relating to seating and parking facilities and such other information as may be requested by the Commissioner. Application forms for hosting tournaments in all sports are provided to each member school by the Association via the KHSAA web site.

The Board of Control shall determine the site of the state tournament after receiving the Commissioner's recommendation, and shall be guided by necessary hotel facilities, playing facilities, and community/area support.

III) Tournament Managers

The Commissioner will appoint a manager for each of the regional tournaments and the team section tournament and shall serve as the manager for the state tournament. The Commissioner may appoint as many assistant managers as deemed necessary to manage the event. It is the duty of each tournament manager to notify the regional schools of the time and place of the tournament as well as the team section tournaments, to supply the proper entry blanks, to invite the participation of all of the schools, and to make all arrangements for the tournament. It is an explicit duty of each tournament manager to inform the association IMMEDIATELY as to the bracket / pairings / entries / results when requested by KHSAA staff and according to the time deadlines provided including the actual site of the tournament if it is not held at the school. The Board of Control has approved the policy that the receipts of a tournament can be assessed (a fine levied against the manager) for failure to comply with these provisions.

IV) Eligibility to Enter Tournament Play

A contestant shall have competed in at least four (4) high school matches on a team representing a member school to be eligible to participate in postseason play. All matches played in a tournament during the season count as one match of the four (4) required to qualify for regional play.

V) Contestants

A school may list entrants using the entry form provided by the Association which is to be submitted to the manager of the regional tournament by the deadline published in the tournament instructions.

This list shall include all names of anyone who is to be eligible to participate in the postseason as additions to the list are not allowed, with the exception of a documented clerical error as referred to in Bylaw 14. Each manager is responsible for the forwarding of the list to future rounds of tournament play.

A school may enter a maximum of two singles players and two doubles teams in the individual singles and doubles regional tournaments. No contestant shall compete in both the singles and doubles competition.

Any player whose name is on the eligibility list may be substituted on a team prior to the time of the draw for the regional tournament. After the draw is final, the regional tournament manager may allow substitution in singles or doubles if the original entry is prevented from participating due to circumstances due to injury/illness. No advantage may be gained by a substitution or it will not be permitted.

The champion, runner-up and other two semi-finalists in both the singles and doubles regional tournaments shall qualify for the individual State Singles and Doubles Tournaments (top 4 finishers from each region.

The regional winning team shall advance to team section play to be held the Saturday prior to the State Tournament,

Any ties for team regional champion honors in qualifying for

section tournament qualifying positions shall be broken using a match (2 of 3 sets) format.

For team competition at the section and state tournaments, the coach shall turn in a roster line-up 30 minutes prior to the match time in rank order 1-10 of individuals that have met all eligibility requirements that may represent the member school in the team section and state competitions. Line-ups may not be changed for that particular contest once submitted to the manager.

The Commissioner's office will issue full instructions to all teams on any additional qualifying procedures.

At the state tournament, prior to the first match, the tournament manager may allow substitution on a doubles team if the original entry is prevented from participating due to circumstances due to injury/illness. No advantage may be gained by a substitution or it will not be permitted. There cannot be a substitute for a singles player.

Players shall participate in all rounds of regional tournament play to be eligible for individual singles and doubles state tournaments.

VI) Rules and Style of Play

United States Tennis Association (U.S.T.A.) Rules shall apply except where modifications are outlined. All match play in both individual singles and doubles shall be best two out of three sets. The tie-break (12 point) as explained in the regional instructions shall be used for both individual regional and state tournament play.

For both the individual regional and state tournaments, the manager may seed the contestants and draw for the remaining places in the tournament. Singles players and doubles teams from the same school shall be placed in opposite brackets. The draw shall be open to the public.

For the State Tournament - Tardiness for Match Participation Regulation:

- 5 minutes or less tardy Loss of toss and loss of one game
- 5:01 minutes to ten minutes tardy Loss of toss and loss of two games
- 10:01 minutes to fifteen minutes tardy Loss of toss and loss of three games
 - · More than fifteen minutes tardy Default

For Team regional (only) play, it will be decided using a 2-2 format (two singles and two doubles) best 2-3 format with a 12 point tiebreak. The coach shall turn in a roster line-up 30 minutes prior to the start of the match time in rank order 1-10 of individuals that have met all eligibility requirements that may represent the member school in the team regaion competition. Line-ups may not be changed for that particular round once submitted to the manager.

For the team section tournaments the following draw has been established for region vs. region winners in scheduling.

For the State Tournament - Continuous play will be in effect for the first two sets with a ten minute break allowed. A two minute break is allowed between the first and second sets. There is no rest period after the first game of any set.

For the team section tournaments the following draw has been established for region vs. region winners in scheduling

The Region Winner listed above shall serve as the host and manage the Section Tournament. The Section Manager may have multiple sites with input from the coaches involved. The four section winners shall advance and compete during the play dates of the individual singles and doubles State Tournaments as scheduled. Members playing in the singles and doubles may represent the member school in the team championship series. Section and State team format shall be 3 singles and 2 doubles, best 2-3 with a 12-point tie-break. The winner shall be declared with one team has won 3 matches and all other play shall stop at that time.

For Regional Individual Singles and Doubles Tournaments, there should be 1 seeded player for everyone four players entered (1 to 4).

VII) Champion

- A) A blind draw will determine which sections winners in the semifinals and final.
- B) Ties in Team Competition
 - In team scoring at the regional tournament (2 singles and 2 doubles), if there is a tie for the champion position, it shall be broken.
 - 2) In the case of a tie in team points to determine regional tournament champion, the playoff shall be scheduled immediately following Regional Tournament play. It is the coach's responsibility to have his/her team on-site ready to play.
 - 3) A brief rest period may be designated by the Tournament Manager if necessary. In the event of inclement weather or darkness, the regional manager may schedule the playoff for the following day.
 - 4) Any regional tournament ties for state tournament individual qualifying positions shall be broken.
 - 5) In the case of a tie in team points to determine the regional champion, the team(s) tied for first who does not win the tie-break procedures will be runner-up; the team(s) that accumulated second-most points during the regional tournament, when there is a tie for first but is not in the tie-break, will finish third and is not the runner-up.
- C) Regional Tournament Winning Team Two-Way Tie-Break
- 1) In the case of a two-way tie in points for the team championship in the Regional Tournament, the number 1 and 2 singles players, and number 1 and 2 doubles teams from each school shall play each other (1 match each, 2 out of 3 sets) to decide the team winner.
- 2) The tie-break matches will be played as follows:
 - a) The #1 singles player from each school will play one (1) match against each other (2 out of 3 games);
 - b) The #1 doubles team from each school will play one (1) match against each other (2 out of 3 games);
 - c) The #2 singles player from each school will play one (1) match against each other (2 out of 3 games);
- d) The #2 doubles team from each school will play one (1) match against each other (2 out of 3 games).
- 3) Each school will have declared their #1 and #2 players in singles and their #1 and #2 doubles teams on the regional entry Form (TN103). These declarations shall be consistent with season play.
- 4) If a school does not have entries in one or more of matches in the brackets of the tie-break round, that match shall be scored as a 6-0, 6-0 victory for the team that has an entry.
- 5) If one of the schools wins either three (3) or four (4) of the matches, then that school shall be declared the winner.
- 6) If neither of the teams has won three (3) or four (4) of the matches, the team winning the most games during the playoff round shall be declared the winner.
- 7) If the application of the tie-break leaves the two teams still tied, the process shall be repeated until a winner is declared.
- D) Regional Tournament Winning Team Three-Way Tie-Break
- 1) In the case of a three-way tie in points for the team championship in the regional tournament, the tied teams shall be ranked by the number of games won during the regional tournament to determine the order of the tie-breaking matches.
- 2) If this ranking results in a tie, it shall be broken by ranking the tied teams in order by the fewest number of games lost.
- 3) If this ranking results in a tie, it shall be broken by a blind draw.

- 4) Following this ranking, the two tied teams ranked lowest shall play each other in the first round of the tie-breaker, with the number 1 and 2 singles players, and number 1 and 2 doubles teams playing each other in a 12-point tie-breaker game.
- 5) Order of play for first tie-breaking round
 - a) Each school will have declared their #1 and #2 players in singles and their #1 and #2 doubles teams on the Régional Tournament Entry Form (TN103). These declarations shall be consistent with season play.
 - b) If a school does not have entries in one or more of matches in the brackets of the tie-breaking round, that match shall be scored as a 7-0 victory for the team that has an entry.
 - c) The 12-point tie-break games will be played as follows:
 - i) The #1 singles player from each school will play one (1) 12-point tie-break game against each other;
 - ii) The #1 doubles team from each school will play one (1) 12-point tie-break game against each other;
 - iii) The #2 singles player from each school will play one (1) 12-point tie-break game against each other;
 - iv) The #2 doubles team from each school will play one (1) 12-point tie-break game against each other.
 - d) If one of the schools wins either three (3) or four (4) of the 12-point tie-break games, then that school will advance to play 12-point tie-break games against the third team in the
 - e) If both schools win two (2) of the 12-point tie-break games, then the school with the most points during the tie-break playoff round will advance to play 12-point tie-break games against the third team.
 - f) If both teams win the same number of points during the tiebreak games, then those same schools will replay the 12-point tie-break games using the same format
 - g) This process will continue until one team advances to play a 12-point tie-break against the third team in the tie break.
- 6) Order of play for second tie-break round
- a) Each school will have declared their #1 and #2 players in singles and their #1 and #2 doubles teams on the Regional Tournament Entry Form (TN #103). These declarations shall be consistent with season play.
- b) If a school does not have entries in one or more of matches in the brackets of the tie-break round, that match shall be scored as a 7-0 victory for the team that has an entry.
- c) The 12-point tie-breaker games will go as follows:
- i) The #1 singles player from each school will play one (1) 12point tie-break game against each other;
- ii) The #1 doubles team from each school will play one (1) 12-point tie-break game against each other;
- iii) The #2 singles player from each school will play one (1) 12-point tie-break game against each other;
- iv) The #2 doubles team from each school will play one (1) 12-point tie-break game against each other;
- d) If one of the schools in this second round of the tie-break wins either three (3) or four (4) of the 12-point tie-break games listed above, then that school will be the regional champion.
- e) If both schools in the second round tie-break win two (2) of the 12-point tie-breaker games, then the school with the most points during the tie-break playoff round will be the regional
- f) If both schools win the same number of points during the tie-break games, then the tie-break process shall be repeated until a winner of this round is declared.
- g) The team losing the second round tie-break shall be declared the regional runner-up.
- E) Regional Tournament Runner-up Two-Way Tie-Break
- In the case of a tie for second place for the team championship in the Regional Tournament, the tie will be broken by the following:
- 1) The team having the highest percentage of games won during the Regional Tournament will be the Regional Tournament Runner-Up. (i.e. Team A plays 200 games and wins 100 games = 50%, Team B plays 198 games and wins 156 games = 78.7%, Team C plays 190 games and wins 150 games = 78.9%). In this example, team C is the runner-up.
- 2) When counting percentages, if one of the tied teams does not

- have a full complement of players (i.e. only one doubles team or only one singles player), then each vacant spot for that tied team will be counted as one 0-6, 0-6 loss.
- 3) If two or more teams have the same percentage of games won, therefore still being tied, all of those teams still tied will be declared regional runner-up.
- 6) Order of play for second tie-break round
- a) Each school will have declared their #1 and #2 players in singles and their #1 and #2 doubles teams on the State Tournament Entry Form (TN104).
- b) If a school does not have entries in one or more of matches in the brackets of the tie-break round, that match shall be scored as a 7-0 victory for the team that has an entry.
- c) The 12-point tie-break games will go as follows:
 - i) The #1 singles player from each school will play one (1) 12point tie-break game against each other;
 - ii) The #1 doubles team from each school will play one (1) 12-point tie-break game against each other;
 - iii) The #2 singles player from each school will play one (1) 12-point tie-break game against each other;
 - iv) The #2 doubles team from each school will play one (1) 12-point tie-break game against each other;
- d) If one of the schools in this second round of the tie-break wins either three (3) or four (4) of the 12-point tie-break games listed above, then that school will be the state champion.
- e) If both schools in the second round tie-break win two (2) of the 12-point tie-breaker games, then the school with the most points during the tie-break playoff round will be the state champion.
- f) If both schools win the same number of points during the tiebreak games, the tie shall not be broken.
- g) The team losing the second round tie-break shall be declared the state runner-up.
- h) Additional revisions to the tie-break procedures will be distributed to the membership upon passage by the Board of Control.
- H) Individual Match Tie-Break Procedures Region and State Tournament
 - 1) All match play shall be two-out-of-three sets.
 - 2) In case of a 6-6 tie in one of the sets, the following 12-point tie-break rules will be in effect for both boys and girls.
 - - a) Player "A" serves first point (right court)
 - b) Player "B" serves points 2 and 3 (left then right) c) Player "A" serves points 4 and 5 (left then right) d) Player "B" serves point 6 (left)

 - e) Players change ends
 - f) Player "B" serves point 7 (right)
 - g) Player "A" serves points 8 and 9 (left then right)
 - h) Player "B" serves points 10 and 11 (left then right)
 - i) Player "A" serves point 12 (left)
 - j) If points reach 6-6, players change ends and continue as before:

 - k) Player "A" serves point 13 (right) l) Player "B" serves points 14 and 15 (left then right)
 - m) Players will continue to alternate two serves apiece until one player establishes a margin of two (2) points
 - n) Change of ends during a tie-break is to be made without any delay other than the 30 seconds allowed between points. Players change ends for one game to start the next set, with Player "B" to serve the first game of the new set.
- - a) The same pattern is followed as with singles, with partners preserving the sequence of their serving turns.
 b) (Assuming "A & B" versus "C & D")
 c) Player "A" serves first point (right court)
 d) Player "C" serves points 2 and 3 (left then right)

 - e) Player "B" serves points 4 and 5 (right then left)
 - f) Player "D" serves point 6 (left)
 - g) Teams change ends
 - h) Player "D" serves point 7 (right)
 - i) Player "A" serves points 8 and 9 (left then right)
 - j) Player "C" serves points 10 and 11 (left then right)
 - k) Player "B" serves point 12 (left)

- I) If points reach 6-6, teams change ends and continue as before
- m) Player "B" serves point 13 (right)
- n) Player "D" serves points 14 and 15 (left then right)
- o) Alternate players on alternate teams will continue to alternate two serves apiece until one team establishes a margin of two (2) points
- p) Teams change ends for one game to start the next set with "C & D" to serve the first game of the new set.
 - q) The set shall be recorded as 7 games to 6. The tie-breaker game shall count as one game for the ball change, except that, if the balls are due to be changed at the beginning of the tie-breaker, the change shall be deferred until the second game of the following set.

VIII) Trophies and Awards

A) Region.

- Trophies will be given to the team winner and runner-up at each region.
- Awards will be given to winning and runner-up singles players and doubles teams at each regional meet.
- 3) The Association will bear the costs of all trophies and medals at the regional meet.
- B) Section.
 - Trophies will be given to the winning team at each section.
- 2) The Association will bear the costs of all trophies and medals at the regional meet.
- C) State.
- Trophies will be awarded to the teams finishing first, second, third and fourth at the state tournament.
- Awards will be given to the winning and runner-up singles players and the two other semi-finalist singles players at the state meet.
- Awards will be given to the winning and runner-up doubles teams and the two other semi-finalist doubles teams at the state meet.
- 4) The Association will bear the costs of all trophies and medals at the state tournament.

IX) Coaching in Region and State

- A) Coaches designated on the KHSAA Region/State Tournament Entry Form (Form TN #103 for Region and TN#104 for State), and approved by the school principal will be allowed to coach between points and any authorized rest/break period and should not delay play. Coaching is NOT permitted when the player changes ends during a tie-break game or during any warm-up period.
- B) There will be an allowance for enough coaches to be on site for each participant/team that is involved. For instance, if a school has one boys' participant in singles competing at Sayre and one boys' doubles team participating at Sayre, two coaches will be allowed passes for that team. If, for example, a school has two girls' singles players participating and two doubles teams participating, four coach's passes will be allowed. This should avoid players not having a coach present should the school's participants be playing at the same time, all coaches shall meet all Bylaw 27 requirements. If additional coach's passes are requested, separate forms shall be turned in. For the State Tournament these request (and individual forms) for additional coach's passes should be presented at the Coaches Pre-Tournament Meeting.
- C) More than one coach coaching at the same time during the same match is prohibited.
- D) Schools found to be issuing coaching passes to unqualified personnel will result in the loss of all coaching passes, except for one head coach, and may result in the disqualification of student participant(s).
- E) The following standards are required for coach communication:
- Only the designated head coach or one assistant coach hired by the school may talk to the players. Parents may NOT talk to the players during these authorized periods.
- Once all championship tournament play is inside the Stadium Courts, all coaching shall be done on the court. Coaching from outside the court will be prohibited.
- Coaches may walk onto/enter the court to coach at the designated appropriate times. Players shall stay on the court with coaches during this communication.
- 4) Players may NOT leave the enclosure unless on a "split-set"

rest period.

- 5) The 90-second period for coaching begins immediately following the last game point, not when conversation begins.
- 6) During the designated coaching breaks, a player may confer with his/her coach. Both singles players and both doubles teams SHALL be at their respective baselines ready to play at the conclusion of the 90-second period. If the break period is NOT adhered to, the following penalties will be applied:
 - a) Both players not ready to play The server starts the next game 0-30.
 - b) The server is not ready to play The server starts the next game 0-30.
 - c) The receiver is not ready to play The server starts the next game 30-0.

X) Finances

A) Region

- The finances of the regional tournament will be managed at the regional level.
- The finances of the Team sectional tournament will be managed at the local sectional level.
- The regional competing schools shall decide any distribution of net profit/loss, which shall be shared.
- B) State
 - 1) The Association will finance the state tournament.
 - 2) Schools are responsible for the expenses of competitors participating in the state tournament.

XI) Special Tournament and Regular Season Rules

A) Specifications for Tennis Courts

The specifications for recommended and required standards for tennis facilities to be used in tournament play may be developed by Association staff and Advisory Committees and approved by the Board of Control.

- B) Dress Code
 - It is recommended that players wear school uniforms during play. The following shall NOT be allowed during tournament play:
 - a) Visible undergarments under either shorts, skirts or shirts.
 Note: Compression shorts, if worn as an undergarment above the knee, are legal.
 - b) Bare midriffs.
 - c) Any garment or hat advertising alcohol, drugs, tobacco products or other inappropriate items deemed objectionable by the KHSAA State Tournament Director.
 - d) Óbjectionable permanent body markings (tattoos) shall be covered; non-permanent body markings (temporary tattoos or body paint) shall be prohibited.
 - e) Black-soled shoes are prohibited.
- C) Additional Rules for Contests

Additional rules developed by the Association may be implemented in contests played in Kentucky and will be distributed to the membership when relevant.

XII) School Personnel to Accompany Team

In accordance with Bylaw 20, each school having participants in a KHSAA event shall send a school designee to accompany the team. This person should be designated in writing by the Principal and approved by the local Board of Education.
