For the past several years the Elizabethtown Board of Education has provided a total student accident insurance policy thru R.J. Roberts, Inc. This policy is a secondary policy that reimburses parents for all "out of pocket" medical expenses, including deductibles. Said policy also provides coverage for all the students involved in all school/district sponsored activities, as well as coverage for athletes during off-season training and out-of-state trips. This student accident plan is endorsed by KSBA and KHSAA. KHSAA provides catastrophic insurance for athletes for 10 years from the date of injury. The cost to renew this program (including preschool) for 2023-2024 school year to include \$7,500,000 Catastrophic Limit is: Cost of policy \$39,538.60
