The Fort Thomas Independent Schools is requesting competitive sealed bids for Custodial Supplies in accordance with the following specifications and conditions.

1. Based on past purchasing history, the estimated value of the proposal is between \$75,000 and \$90,000 annually. Fort Thomas Schools does not guarantee any quantities or dollar amount and actual purchases may be more or less. Purchases will be as needed with no minimums required.
2. Once approved by the Board of Education, contracts will be in force with vendors from July 1, 2025 until June 30, 2026. Fort Thomas Independent Schools reserves the right to extend these agreements under the same terms and conditions, with the approval of the successful awarded parties, for no more than two (2) additional one-year agreements.
3. **Proposal prices must include any and all delivery charges. If delivery, shipping, or handling fees are to be charged such charges shall be outlined in the General Comments / Considerations / Information section located at the end of the Bid List.**
4. Where applicable, brands and part numbers are included in these bid documents. Brand names and part numbers listed are products currently in use by the district, products used satisfactorily in previous years by the district, or preferred items based upon current information. Alternates are allowed where indicated, but must be equal in quality, suitability, to purpose and must be comparable. Fort Thomas Independent Schools will accept samples of proposed alternates as long as they are received prior to the scheduled proposal opening. Samples will not be returned.
5. Vendors are not required to submit bids that include prices for all items. They may choose to exclude items on a case by case basis if they do not wish to be considered for that particular item.
6. Fort Thomas Independent Schools reserves the right to reject any and all sealed bids submitted and to request any additional information from all proposers.
7. It is not the policy of Fort Thomas Independent School to purchase on the basis of low bids alone. Quality and suitability to purpose being controlling factors, it is understood that the purchaser reserves the right to arrive at such by whatever means may be determined. The following criteria shall be used to evaluate each proposal:
 - a. Purchase Price
 - b. Reputation of vendor and of the vendor's goods or services
 - c. Quality of vendor's goods or services
 - d. Extent to which the goods or services meet the district's needs
 - e. Vendor's past relationship with the district
 - f. Total long-term cost to the district to acquire the vendor's goods and services
 - g. Any other relevant factor specifically listed in the request for proposal
8. Proposals should include in the General Comments / Considerations / Information section any information you would like for us to consider when making our decisions.

9. Upon approval by the Board of Education, if required, contracts for purchase will be put into effect by means of purchase orders issued by the Director of Operations for Fort Thomas Independent Schools.
10. Model Procurement Regulations – The Model Procurement Regulations adopted by the Fort Thomas Board of Education shall be deemed incorporated by reference into these specifications as though fully quoted herein. In the event of any conflict between this request for proposal and the Model procurement Regulations, the Regulations shall control.
11. Fort Thomas Independent School's tax-exempt status applies in accordance with revenue policy 51P370P370 revised 06/01/1983 and in accordance with 103 KAR 26:070. A state sales tax exempt certificate shall be provided to the awarded vendor(s) upon their request.
12. In addition to supplying the Fort Thomas Independent Schools with custodial and maintenance products, companies shall be prepared to assist the district in training programs designed to present their products to our staff and instruct them in proper use.
13. Price Redetermination: Prices quoted shall be firm and fixed unless otherwise stipulated in the Invitation for Bid. For multiple year contracts, prices shall remain firm and fixed during the initial term of the contract. At the end of the initial contract term, and at the end of each contract term thereafter, the Contractor may request a price adjustment. Such requests must be submitted in writing at least 60 calendar days prior to the end of the contract term and shall include the cause for the adjustment, the amount of change requested, and documentation to support the requested adjustment.

During the term of the contract, a Contractor may request a price redetermination. Only pass through price adjustments will be considered and any proposed price increase must be proven to be general throughout the industry. Requests for price increases must be accompanied by enough documentation to justify the request including, for example, certified letters from a manufacturer or published price indices such as the Producer Price Index that substantiate a price increase.

“Prohibition against Conflicts of Interest, Gratuities and Kickbacks”

Any employee or any official of the Board of Education of Fort Thomas Independent Schools, Fort Thomas, Kentucky, Elective or Appointive, who shall take, receive, or offer to take or receive, either directly or indirectly, any rebate, percentage of contract, money, or other things of value, as an inducement or intended inducement, in the procurement of business, or the giving of business, for, or to, or from, any person, partnership, firm or corporation, offering, bidding for, or in open market seeking to make sales to the Board of Education of Fort Thomas Independent Schools, Fort Thomas, Kentucky shall be deemed guilty of a felony and upon conviction such person or persons shall be punished by a fine not to exceed five thousand dollars (\$5000) or by imprisonment in the penitentiary for not less than (1) year nor more than ten (10) years, or both so fined and imprisoned in the discretion of the jury.

Every person, firm, or corporation offering to make, or pay, or give, any rebate, percentage of contract, money or any other thing of value, as an inducement or intended inducement, in the procurement of business, or the giving of business, to any employee or to any official of the Board of Education of Fort Thomas Independent Schools, Fort Thomas, Kentucky, elective or appointive, in his efforts to bid for, or offer for sale, or to seek in the open market, shall be deemed guilty of a felony and shall be punished by a fine not to exceed five thousand (\$5000) or by imprisonment in the penitentiary for not less than one (1) year nor more than ten (10) years, or both so fined and imprisoned in the discretion of the jury.

NOTE: It is a misdemeanor not to have this Prohibition on every solicitation or contract document. The Penalty is a \$5000 fine or 1-year imprisonment or both on conviction.
