Each Monday morning, our district leadership team meets to plan upcoming events and share ideas to improve student opportunities and instruction.

Each Tuesday morning, our district facilities team meets to review submitted work orders and discuss maintenance projects that need to be completed throughout the district.

9/25/25	Attended the Jazz Educator Big Band Performance at Newport High School with Newport Intermediate and High School students. This event exposed our students to jazz music and various types of musical instruments.
9/29/25	Attended the Northern Kentucky Education Council Fall Convening at the Ignite Institute with Ms. Stubbeman and Ms. Malone. The event was well attended by Northern Kentucky educational and political leaders, and a highlight was the unveiling of the <i>Elevate NKY</i> data dashboard.
9/29/25	Met with my new superintendent mentor, Ms. Misty Middleton, superintendent of Bellevue Independent Schools.
9/30/25	Met with Scott Hawkins, Executive Director of Mentoring and Coaching for the Kentucky Association for School Administrators. Mr. Hawkins will serve as my executive coach for the school year.

## Standard 2: Instructional Leadership

This month, I would like to highlight our focus on instruction. We are beginning instructional rounds in all schools—a professional learning process where teachers, principals, and district leaders visit classrooms together to observe teaching and learning around a specific focus area. Modeled after medical rounds, the goal is not to evaluate teachers but to build a shared understanding of effective instruction. After classroom visits, the group will analyze observed patterns and identify next steps to improve teaching and learning across the district.

I would also like to highlight the collaboration taking place between our district and external partners. This month, Melissa Wainwright, KDE MTSS Coordinator, visited and met with Autumn Slankard to review our MTSS systems and processes and to provide feedback on next steps. We have also collaborated with NKCES by attending their High-Quality Instructional Resource (HQIR) trainings in Cold Spring. Additionally, NKCES will visit Newport on November 11 to provide instructional coaching at no cost to the district.
