Meeting called to order at 3:51 PM by Chairperson Meyers

1. Opening Business
 - a. Approval of the Agenda
 - i. Motion to approve the agenda made by Mr. Fitzgerald, second by Mrs. Kohrs. No objections.
 - b. Approval of the October Minutes
 - i. Motion to approve the October minutes made by Mr. Ratterman, second by Mrs. Kohrs. No objections.
 - b. Good News Report
 - i. Mr. Meyers announced that Dayton High School was recently certified as a Family Friendly school by the Pritchard Committee.
 - ii. Mr. Meyers proudly shared Dayton Middle and High School's KSA results. The middle school went from Orange to Yellow and the high school from Orange to Green. The high school is also ranked in the top half of the high schools in the state of Kentucky.
 - iii. Mr. Meyers commented on the decent success of our second Family Engagement Day. As a middle school and high school, we contacted 64% of our families. He also shared results of a survey we encouraged families to complete. There were 77 responses. Some answers that stuck out were: 93.5% of the respondents said their child has a trusted adult within the school; 67% of the respondents said their child was either very or somewhat comfortable reporting bullying incidents to school staff.
 - iv. Mrs. Kohrs shared the success of our Lean Six Sigma Yellow Belt program with a group of juniors and seniors. Two seniors already became Career Ready through the program and there are 5 more seniors lined up to also become Career Ready.

- i. Post-Secondary Numbers Update
 - 1. Seniors – 30/42 (71%)
 - 2. Juniors – 13/61 (21%)
 - 3. Sophomores – 9/59 (15%)
 - 4. Freshmen – 1/59 (2%)
- ii. KSA Update
 - 1. Dr. Wright shared information about our 2025 KSA results-namely the middle school's jump from Orange to Yellow and the high school's jump from Orange to Green.
- iii. DHS CSIP
 - 1. Dr. Wright offered an overview of Dayton High School's CSIP.
 - 2. Required Goals
 - a. Achievement Gap Goal-The economically disadvantage middle school students will grow from 20% P/D (Proficient/Distinguished) to 35% P/D on KSA Science Assessment and 16% P/D to 35% P/D on the KSA Social Studies Assessment
 - b. Reading & Math
 - i. 3 Year Goal-Dayton Middle will increase the number of P/D students in reading to 65%.
 - ii. 3 Year Goal-Dayton High will increase the number of P/D students in math to 65%.
 - c. Optional Goal
 - i. 3 Year Goal-DHS will hit 100% postsecondary status with all graduating seniors.
 - 3. Dr. Wright also discussed all of the strategies and activities that DHS has implemented in order to reach these goals.
