Bluegrass Middle School is nestled in between it's feeder schools New Highland Elementary school and John Hardin. This unique setting enables us to structure our vertical programs to work together. This blending of schools, as well as the unique draw of our communities creates a large level of diversity which is one of our strengths. Our population is currently 605 students - 65% of whom qualify for free/reduced lunch and 48% of whom are minority students. Even though Bluegrass is located in Etown Kentucky and is adjacent to Fort Knox it still has a uniquely urban and rural feel. We have a wide variety of programming that students can access including band, art, PE, careers, We Build it Better (a partnership with Altec), agriculture education, LEGO Robotics, and technology. We are a 1:1 school with all students receiving chromebooks. Teachers are equipped with interactive panels, wireless slates, webcams, wireless microhpnes, and cameras to assist with teaching. Our whole school has invested in project/problem based learning.
