

Comprehensive School Improvement Plan (CSIP)

Rationale

The CSIP is a plan developed by the school council with the input of parents, faculty and staff based on a review of relevant data that includes targets, strategies, activities, a time schedule to support student achievement and student growth and to eliminate achievement gaps among groups of students. Through the improvement planning process, leaders focus on priority needs, funding and closing achievement gaps among identified subgroups of students.

While the focus of continuous improvement is student performance, the work must be guided by the aspects of teaching and learning that affect performance. An effective improvement process should address the contributing factors creating the learning environment (inputs) and the performance data (outcomes).

Please note that the objectives (yearly targets) set by your school under the Achievement Gap section of this planning template will be used by the district's superintendent to determine whether your school met its targets to reduce the gap in student achievement for any student group for two consecutive years as required by KRS 158.649. - **Activity:** Actionable steps the school will take to deploy the chosen strategy. There can be multiple activities for each strategy;
- **Progress Monitoring:** Process used to collect and analyze measures of success to assess the level of implementation, the rate of improvement and the effectiveness of the plan. Achievement Gap

KRS 158.649 requires the school-based decision making (SBDM) council, or the principal if no council exists, to set the school's yearly targets for eliminating any achievement gap. The targets should be established with input from parents, faculty and staff and submitted to the superintendent for consideration and the local board of education for adoption. In addition to being a statutory requirement, intentionally focusing on the achievement gaps that exist among a school's underserved student populations is also a vital component of the continuous improvement process. Schools should use a variety of measures and analysis when conducting its review of its achievement gaps, including a review of the school's climate and culture. Schools are not required to establish long term achievement gap goals; however, schools must establish yearly targets. Additional rows may be added for multiple targets, strategies and activities.

Objective(s):

By 2026 decrease the percentage of SPED students scoring novice on reading from 43% to 40% and the decrease the percentage of SPED students scoring novice on math from 45% to 42%.

State Assessment Results in Reading and Mathematics

Kentucky's accountability system uses multiple academic and school quality measures, with each indicator contributing to the overall score. Reading and math proficiency are foundational to student success, and state assessment results in reading and mathematics carry the greatest weight when calculating the overall score at each level (elementary, middle and high school). This indicator is a required goal area for all schools.

Three- to Five-Year Goal:

By 2028 the percentage of students scoring proficient or distinguished on Reading KSA will increase from 57% to 65%. The percentage of students scoring proficient or distinguished on Math KSA will increase from 46% to 54%.

Objective(s):

From 2025-2026 the percentage of students scoring proficient or distinguished on Reading KSA will increase from 57% to 60%. The percentage of students scoring proficient or distinguished on Math KSA will increase from 46% to 50%.

Strategy:

KCWP 2. Design and deploy instruction. KCWP 1. Design and deploy Standards.

Activities:

-Apply knowledge from best practices and research based curriculum (OG, iReady, Thoughtful Ed, Fontas and Pinnell, Magnetic, FNTC/Epic Numeracy Grant) to implement instructional tasks that are aligned to curriculum pacing guides and lesson plans. Ensure regular PLCs and SBDM committee meetings to evaluate pacing, assessment measures, and vertical alignment. Use formative and summative assessment results to inform what comes next to advance students' learning paths. Utilize summer slide learning packets and summer learning opportunities if funding is available.
