Just outside the gates of Fort Knox, Radcliff Elementary houses grades 1-5 and is located in Hardin County, in the city of Radcliff. According to the most recent information, this area has an unemployment rate of 5.2% with approximately 20% of families living in poverty. The median household income is reported at \$54,558. Approximately % of the students at Radcliff Elementary School participate in the Backpack Program that provides food on Fridays for the weekend. There are approximately 403 students at Radcliff Elementary; however, students move in and out frequently with approximately 15% of our student population being transient throughout the year. Approximately 55 % of our student population is minority. Although more than 80% of our students qualify for free or reduced lunch, all of our students receive free breakfast and lunch because we are identified as Community Eligibility Provision school. In addition, approximately 23% of our students receive mental health services through local agencies and Cumberland Health- a company working closely with our entire school district to provide health services to our students. Currently we have 32 certified staff members, 20 classified staff members, 1 counselor, 1 interventionists, 1 assistant principal, 1 principal, and 1 family resource coordinator. Radcliff Elementary continues to experience significant staff turnover. We have implemented, and are maintaining multi-sensory strategies in both reading and math, and have embraced Discovery Education as a tool to use with both social studies, and science. Teachers are intentional in their planning of hands-on activities.

Stakeholders at Radcliff Elementary include students, staff, families, and community members.
