## BID #32-11-11-12 - MIDDLE SCHOOL YEARBOOKS

The bid documents for the middle school yearbook were sent to five vendors and four of these companies submitted bids. We are recommending awarding this bid to Taylor Publishing on the basis of lowest cost. Taylor Publishing has printed our high school yearbooks for several years and has done an excellent job.

## BID #33-11-11-12 – ELEMENTARY SCHOOL YEARBOOKS

All elementary schools are now selling yearbooks to their students. Some schools use the hard cover and some use the soft cover. We are recommending that each principal choose the vendor that offers the best price for the type of yearbook they choose to offer for their students. The best prices are highlighted on the attached bid tabulation sheet.

## BID #31-11-11-12 – HIGH SCHOOL YEARBOOKS

The bid documents for the High school yearbook were sent to five vendors. One of these companies submitted a bid. We are recommending awarding this bid to Herff Jones on the basis of lowest cost. Herff Jones is the yearbook publisher for several surrounding schools including Union County and has a very strong reputation. The prices bid by Herff Jones are very competitive with the previous years bid.

## BID # 30-11-11-12 - WORKERS COMPENSATION BID

The bid documents for the Workers Compensation bid were sent to five vendors whose addresses were on file from previous bid years and were posted online as per normal practice. There were 2 responses from the bid packets mailed and one from an insurance company who pulled it off our website. E.M. Ford submitted the lowest price bid. The bid came from our current Workers Compensation insurance provider Kentucky Employers Mutual Insurance (KEMI). We recommend that the bid for Workers Compensation be awarded to EM Ford based on the lowest bid price.

## **BID RENEWAL**

A letter was mailed to our current Refuse pick up provider Allied Waste Services requesting a renewal of our current contract # 38-08-9-11. Allied Waste Services agreed to continue our current contract beginning January 1, 2012 and ending December 31, 2012.
