I am contacting you today regarding the proposed realignment for soccer from the e-mail sent by Commissioner Tackett on Friday, November 18, 2011. I have attempted to respond via Survey Monkey however the link that was provided is not working correctly.

The Calloway County School District is supporting an alternate alignment proposal for district one and two that resembles how the districts are currently aligned. This proposal would limit the mileage that all the teams would be traveling, which in turn allows more time for arrival to an away match and allows kids to get home earlier on school nights. This proposed alignment also keeps in place established rivalries, in district play.

District One: Ballard Memorial, Community Christian, Paducah Tilghman, St. Mary, McCracken County(2013)

District Two: Calloway County, Graves County, Marshall County, Mayfield, Murray
