Background

- DRAFT SOCCER ALIGNMENT OF SCHOOLS FUNDAMENTAL PREMISE – IN SAME REGION AS BASKETBALL
- Issue for St. Patrick and Mason County because no other school in our basketball District has a soccer program.
- This leads to excessive travel time for St. Patrick and Mason County under the KHSAA Draft Revised Soccer Alignment.

Request and Proposed Solution

- St. Patrick and Mason County respectfully request KHSAA Commissioners and Board of Control consider and approve relocation of St. Patrick and Mason County Soccer from District 38 to District 61
- The solution proposed by St. Patrick and Mason County accounts for other impacted schools and is a win/win resolution for all impacted parties – as explained on subsequent slides
- St. Patrick and Mason County believe implementation of their request would not result in delay of final adoption or 2012 effective date

Win/Win Solution – Region 16

- **District 61**
 - St. Patrick and Mason County travel issue resolved
 - Menifee County moves to District 62
 - In same District as “nearby” Elliott County
 - Relative close proximity to Carter County
- **District 62**
 - Greenup County moves to District 63
 - Greenup County is a much better fit in District 63 because it's close to all District 63 soccer schools
