As requested, Sherman Carter Barnhart has solicited proposals from Alliance Corporation (General Contractor), as well as from other local acoustical contractors to install 1-1/2" thick spray-on acoustical treatment (standard color) in the Gymnasium at North Middle School.

On Wednesday, May 30, 2012, Sherman Carter Barnhart received proposals from Alliance Corporation, Thermospray of Lexington, Bland's Insulation, Inc., and Omni Fireproofing Co, LLC.

Per Kentucky Department of Education, if three or more bids are received to provide and install the acoustical treatment, the school board may award the work to a contractor other than the general contractor, and project contingency funds may still be used. The school board is required to do the following:

- Award project to the preferred contractor
- Approve a "draft" AIA Owner/Contractor agreement (SCB will generate)

The board meeting minutes awarding contract, approving the "draft" Owner/Contractor agreement, as well as the bid tab form must then be submitted to KDE for approval.

These items must be approved at the June 21 school board meeting and immediately forwarded to KDE in order for the acoustical contractor to start work in July, immediately following the completion of the gym wood floor refinishing. In the past, KDE has agreed to review the bid tab form and the "draft" agreement in order for KDE's approval to be ready immediately after school board approval. If this is possible, this will allow enough time to conduct a pre-installation meeting with the contractor, for the contractor to order materials, and make preparations prior to start of installation in July.

Sherman Carter Barnhart recommends that the Hardin County Board of Education award the acoustical treatment installation to Thermospray of Lexington, Inc. Their proposal amount, experience, and positive track record for acoustical installations makes them the best contractor to conduct this work.

to the gymnasium at the above school in the following manner:

1. We will double layer the gym floor with 6 mil poly;
2. We will poly the walls, goals, lights, scoreboards, fans, exhaust, fans on wall, speakers on wall,
speakers on goals, ducts and put aluminum foil on sprinkler heads;
3. We will spray top cord of bar joist and clean over spray off remaining parts of joist;
4. We will remove debris and broom clean after spraying is complete.

water.
