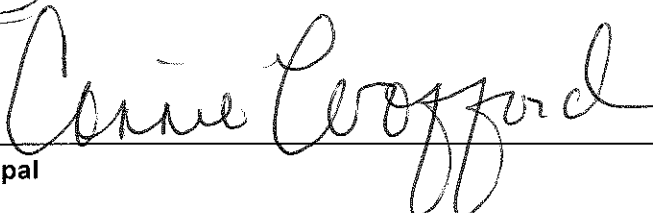

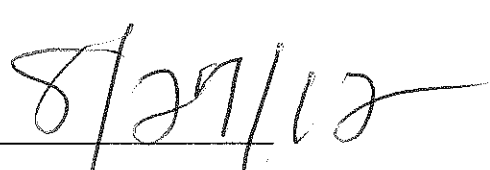

Funds raised will go toward Art Club supplies. All members in the art club who create the buttons and magnets will benefit by having more art supplies to use before/after school.

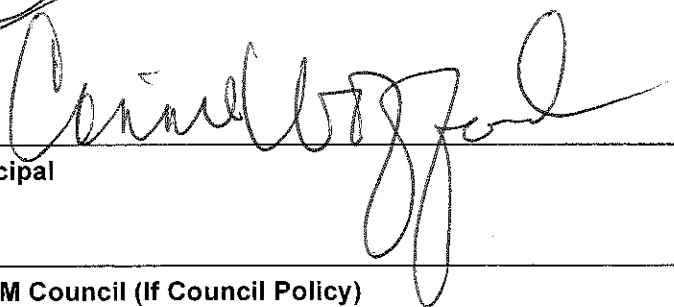
