**CAMPBELL COUNTY SCHOOL DISTRICT  
DISTRICT FACILITIES HEARING REPORT**

A public hearing was held at the Campbell County AEC Building on October 1, 2012, at 5:30 p.m. (local time). The purpose of the public hearing was to propose a new District Facility Plan developed by the Campbell County Local Planning Committee. The Local Planning Committee (LPC) voted 12 – 0 in favor of the proposed new plan and the Board voted 4 - 1 to approve the new plan.

There was one person at the hearing exclusive of the hearing officer, in attendance. Mike Oder, KSBA Facilitator served as the locally-appointed hearing officer. Kerry Hill, Central Office staff member and LPC Chairman was present.

**COMMENTS**

Kerry Hill, Campbell County Central Office staff member called the public hearing to order. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 4:180. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes:

Long range plan of school organization to P-4, 5-6, 7-8, 9-12.

- New construction of: 900 student Intermediate School (grades 5-6)  
900 student Middle School (grades 7-8)

Renovation and new construction at:

- Campbell County High School including roof, HVAC and renovation of 10 classrooms for a technology academy.
- Reilly Elementary School to include site, exterior, interior, HVAC, electrical, hallway and cafeteria addition.
- Cline Elementary School to include site, exterior, interior, HVAC, electrical, plumbing and elevator. Construct cafeteria addition
- Grants Lick Elementary School to include ADA, site, interior, HVAC, electrical and plumbing.
- Future demolition of Alexandria Education Center, McCormick Area Technical Center and Central Office.
- Construct new Central Office.
- Renovation to bus garage and maintenance building.

The floor was opened to those who wished to make a statement. No statements were made.

## **RECOMMENDATIONS**

It is recommended that the new District Facility Plan developed by the Campbell County Local Planning Committee and adopted by the Campbell County Board of Education be approved as the District Facility Plan for the Campbell County School District. A copy of the new plan is attached.
