## **Professional Services Agreement**

This Professional Services Agreement (hereinafter referred to as "Agreement") is entered into on January 7, 2013 by and between Colleagues on Call, an Arizona Limited Liability Company, and **Elizabethtown Independent Schools, Kentucky** (hereinafter referred to as "Customer"), and is subject to the following terms and conditions:

- I. Customer contracts for Colleagues on Call Professional Services, entitling Customer to receive:
  - Consultant services from John Antonetti to be delivered on the following dates:

August 5, 2013 September 16, 2013 November 5, 2013 January 2014 (date to be determined) March 2014 (3 dates to be determined)

- Fee is \$5500.00 per day, all-inclusive of travel, lodging, and related expenses.
- Total contract price: \$38,500.00

# II. General Provisions.

- a. GOVERNING LAW. Unless otherwise specified by state law, this Agreement is made and entered into in the State of Arizona and the internal laws of said state shall govern the validity and interpretation hereof and the performance by the parties hereto of their respective duties and obligations hereunder.
- b. <u>CONSENT TO JURISDICTION</u>. Unless otherwise specified by state law, all parties agree that all suits, actions, or legal proceedings arising out of this Agreement may be brought only in a court of competent jurisdiction in Maricopa County, Arizona. Each party consents to the jurisdiction of such court in any such suit, action, or proceeding.
- III. <u>Intellectual Property Rights:</u> Customer acknowledges all documents and electronic media presented are owned exclusively by Colleagues on Call. Any reproduction requires prior, written permission from the presenter.
- IV. <u>Payment Schedule and Terms.</u> The following represents the payment to be received by Colleagues on Call from Customer, and the scheduled payment date. The term of the contract runs from execution through March 31, 2014.

Customer will be invoiced in July 2013 with payment to be made in full within 30 days of August 5, 2013.
