All Sports - Regular Season - An additional local mileage / travel allowance may be established by regional policy board for regular season contests and mileage/travel is the only adjustment in fee which can be made. Postseason- $\$ 5$ additional is added to the base fee if the assignment location is not in the normal service area (local association) of the official.
All Sports - Postseason - Mileage allowaance for KHSAA postseason competition at press time is $\$ .35$ per mile.
Board of Control Standard Fee Review Schedule - The Board will routinely review fees in all sports on a defined schedule in the fall of the year prior to implementation of any change. In the interim, changes will only be considered if there is a change in playing rules or number of officials that necessitates emergency review.
