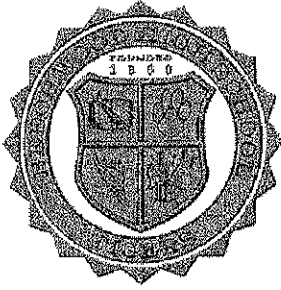

RE: Prime Date Final Analysis

On February 18, 2013 Gary Lawson ran a final schedule audit and found 14 of our member schools that play girls basketball to be out of compliance with our 40% Prime Date requirement. All fourteen of these schools requested waivers due to weather postponement or cancellation from an opposing school. The following is the list of schools that were granted a Prime Date Waiver for the 2012-2013 Girls Basketball season:

Associate Commissioner Darren Bilberry:

This letter is in response to a phone conversation Mrs. Wera had with Gary Lawson today concerning us being out of compliance with our girls basketball schedule for the just recently completed 12-13 season.

We are requesting a waiver for prime time requirements to our girls' basketball schedule based on the following criteria listed below:

1. The Beechwood girls' schedule was in compliance at the beginning of the season (per our home schedule)
2. Our Saturday December 29<sup>th</sup> game at the Greenup Co. tournament was cancelled because of weather.
3. This caused us to alter our schedule and we added a home game with Bracken Co. on Feb. 12<sup>th</sup> (Tuesday)
4. After we lost in the All A, we added two home games, which would have kept us on track to meet the requirement of 40% of our combined H/A games.
  - a. Home vs. Walton Verona on Friday, Jan 11
  - b. Home vs. Campbell County on Thursday, Jan 31
5. Weather related cancellation - the game scheduled for Saturday, February 2nd at home vs. Lloyd was cancelled because of snow. We rescheduled the game for Monday, February 4 because it was a required game as part of our affiliation with the NKAC Division II. Friday Feb. 8<sup>th</sup>, Saturday Feb. 9<sup>th</sup>, Friday Feb. 15<sup>th</sup>, and Saturday Feb. 16<sup>th</sup> were not options.

Thank you for your consideration of the waiver.

Mr. Billberry,

It has been brought to my attention that our girls' basketball schedule has not met the 40% prime time date criteria. It is my intention to explain what happened with our schedule for this season.

On Nov. 27, 2012, Gary Lawson called me to inform me that our girls' schedule only came in at 38.5% for prime time dates. After reviewing the schedule with Mr. Lawson, I called our girls' coach, Lincoln Spence, and informed him that he needed to pick up another prime time date, as Coach Spence always does his own scheduling. Coach Spence informed me that he was, actively, trying to pick up games to get us where we need to be and he had e-mail verification to prove that. He managed to pick up two games in the Belfry Mountain Schoolgirl Classic. Both of these games were on prime time dates, which put us over the 40% requirement.

Shortly, before, our Saturday, December 15 game date at South Floyd, Coach Isaac from South Floyd called to cancel the game due to travel concerns and a potential lack of numbers at that point. Rather than just forfeit the game and have to pay a cancellation fee, both coaches agreed to push the game back to next season. Even with this cancellation, we still met our 40% requirement.

Moving on to February, we were still in good shape until we had a Feb. 1 game with Jackson City get postponed due to severe weather.

Then, our Feb. 8 date with South Floyd, also, was dropped due to the fact that they had to get a district game in on that date for seeded purposes. It was agreed that the Feb. 8 game would be pushed back to next season, along with the earlier Dec. 15 game. We have e-mail verification from Coach Isaac for both of those dates if need be.

In summation, after the initial phone call from Mr. Lawson, we picked up two additional games to put us over the 40% criteria for prime time games. Coach Spence, even, before the call from Mr. Lawson was seeking games to finish out our schedule and get us in compliance. The two games at Belfry on December 28 and 29 put us over our 40% requirement. Once the December 15 was dropped, we were still in compliance with the requirement. From there, we were in compliance until February where we ran into issues with weather and with South Floyd needing to get a required district game in. We do have e-mail verification of every statement we have made within this letter and can supply that to you at your request. Feel free to call me at (606) 471-5213 or Coach Spence at (606) 594-3415. Commissioner Bilberry,

I am sending this e-mail to request a waiver of the primetime date rule for the Cordia Lady Lions Basketball team. I am requesting this waiver based on cancellation of games due to lack of players. At the beginning of the season we were in compliance with the 40% rule (were actually 7/14 or 50%). We finished the season @ 32%. Throughout the last 2/3 of the season we struggled to keep enough girls to even play. On several different occasions we dropped down to three(3) players on the roster. Each time we dropped down to 5th/6th grade girls (non of which were previously on the team) to have enough to play. We finished the season with 7 players which was only because of the Head coach and her staff's hard work and determination. Twelve games were either cancelled or rescheduled, the games that were rescheduled were all District games that had to be played due to seeding. Some examples of these struggles were games on 12/22/12 against Phelps HS which was a primetime date. On game day Coach Webb only had three girls show up so that game had to be cancelled. The same situation occurred on: 1/7 vs. Owsley Co., 1/9 vs. Buckhorn, 1/19 vs. Phelps, 1/26 vs. Oneida Baptist, 2/4 vs. Riverside, 2/11 vs. Betsy Layne, and 2/16 vs. Jenkins. Five of these dates were Primetime dates. Several attempts were made to reschedule on primetime dates but were for the most part unsuccessful, we literally played on a day to day basis not knowing if we would have enough to play.

Every attempt possible was made to increase interest in playing by Coach Webb and her staff. By season's end she had enough players to compete in post season play by getting several elementary age students. Coach Webb and her staff will give this program something that it hasn't had in quite awhile...stability. In the past 4 years we have hired 6 different coaches. Hopefully the new coaching staff will aide us to assure that this problem doesn't occur again. Thank you for your time and please let me know if you need any further information pertaining to this waiver.

Mr. Bilberry,

I am contacting you on behalf of Elliott County High School on our compliance status as it relates to Prime-Time scheduling and requesting a waiver for this occurrence. On November 27<sup>th</sup> of last year I had spoken with Mr. Lawson about our girls' basketball schedule being out of compliance according to Title IX. We corrected this situation due to the fact that we had not officially received notification of participation in a shootout that was held on December the 18<sup>th</sup> against Ironton High School at Coal Grove. This was later added to the schedule on the KHSAA website.

After the season, it was brought to our attention that our girls schedule was out of compliance again. This was a result of two factors. First, a game that was to be played on January 18<sup>th</sup> against Greenup County was moved was rescheduled on February 6. This was a request by Greenup County because their head coach would not be able to attend the game. We tried to work on finding dates that would keep us in compliance but our schedules did not allow for this. Second, according to the KHSAA site our first round game in the 16<sup>th</sup> Region All "A" Classic on January 12 against Menifee County was played at Raceland. However, the format of the tournament allowed the first round games to be played at a host school and we held this game at home. I have tried to change this on the website but the games are locked and it would not let me do so.

If the wavier is approved the way that I have us meeting compliance is through our home games method.

Mr. Bilberry

I am writing to inform you of the reason Jenkins High School ladies basketball team did not meet the requirements of the 40% rule. First, Gary Lawson contacted me on 11/7/2012 and informed me that we were currently did not meet the requirement, as we had 36.7% home games scheduled. I informed him that the schedule was originally within the requirements, but South Floyd had recently asked to reschedule the 11/30/12, but a date had not yet been established. We then discussed that adding one prime home game in December would take care of the issue, just in case we could not get a prime date with South Floyd. Following Mr. Lawson's advice we added Lynn Camp on 11/7/12. A few days later we added South Floyd for 2/2/13 which was a prime date as well. With the two additions we were well over the needed 40% of games being played at home on prime dates.

However, for several reasons beyond our control, we finished the season below the 40% mark. First issue came with the 1/5/13 contest with Cordia High school. Their coach cancelled the game and we had great difficulty in rescheduling the game, in fact the game was not played until the day before the last day seeded games had to be played. If needed I can provide e-mails documentation from both myself and Coach Addington detailing the difficulty in getting Cordia to play both district games. The second issue came from the Belfry game scheduled on 1/12/13, Belfry was unable to travel this day because the Pike County school system suspended all events on this day for the funeral of former superintendent Frank Welch, unfortunately another prime was not available that fit the scheduling issues of either school. The next two issues came on 2/1/13 with South Floyd and 2/2/13 with June Buchanan School (JBS). Considering Jenkins has the highest elevation of any town in Kentucky we are prone to weather conditions that most towns do not face. This is the case for these two games, as inclement weather forced us to be unable to reschedule anything with South Floyd, and the persistent cancellations with Cordia forced us to move the JBS to a non-prime date, because we still had to play both Cordia and JBS two games each in the next ten days, as both are district opponents. It was impossible to reschedule prime dates on these games because the season was nearing the end and conflicts prevented prime dates.

Overall we place a high priority on both male female athletics at Jenkins High School and myself and the school administration strive to promote the welfare and fairness for all participants. However, several events beyond our control pushed us below the 40% mark. Nonetheless, the complications have shown us the need to schedule more prime dates earlier in the season, as this would allow us more flexibility in rescheduling inclement weather dates.

Thank you for considering our appeal and understanding that the events that pushed below the 40% mark were beyond our control.

Mr. Bilberry,

I am writing in concern for a weather related waiver on behalf of our percentage of prime time games. We originally submitted a schedule that was in full compliance with Title IX game requirements. We were at prime time numbers of 6 of 13 for 46.2% of games and total of home numbers of 18 of 30 for 40%. We lost two home prime time games due to severe weather of ice and snow on January 19th with a home game against Knoxville Catholic and on January 25th against Wayne County. We tried to reschedule with both schools with an emphasis on prime time dates. We were not able to reschedule with either team for any date including prime time dates due to conflicts of schedules and lack of prime time dates left in the last three weeks of the season. We were able to replace one game with a game at home against Hazard but it was unable to be a prime time date. We did try using all means to add another prime time date but was unsuccessful. This effort along with the uncontrollable nature of the weather we experienced is why I am asking for a waiver for our noncompliance on this issue. I would appreciate your understanding in this matter, thank you!

However both of these games were cancelled due to weather. Due to the 30 game schedule and the shortened season, as well as our gym schedule we could not reschedule these on a prime time night.

The third games was with June Buchanan School on January 26. They called and canceled and would not re schedule.

Commissioner Billberry:

This letter is in regards to Robertson County High School (formerly Deming High School) Girls Basketball Title IX Compliance. Test 2 on November 26<sup>th</sup>, 2012 showed the schedule to be in compliance. The school was informed this week that a test completed at the conclusion of season showed Robertson County School to not be in compliance. During the course of the season, three prime time dates were cancelled. Two were rescheduled on non-prime time dates. The other was not rescheduled.

Deming was scheduled to play an away game against Augusta Saturday, December 8<sup>th</sup>, 2013. The game was rescheduled at the request of Augusta's coach to Saturday, January 12<sup>th</sup>, 2013. On Friday, January 11<sup>th</sup>, 2013 one Robertson County player's grandfather and close personal friend of the coach passed away. Out of respect for those people and due to the fact there were only six girls on the team at that time, the game was rescheduled again. All Saturdays were scheduled to the end of the season. February 8<sup>th</sup> was only feasible prime time date. Both schools decided not to play the 8th because both played in the Bluegrass Conference Tournament the next day in Berea, a long trip. This led to using February 7<sup>th</sup>, 2013 for that game.

Silver Grove was scheduled for Friday, February 1<sup>st</sup>, 2013. Robertson County School was out for snow that day. The game was cancelled for that reason. The only open primetime date for both schools was on February 15<sup>th</sup>, 2013. This was also Homecoming for Robertson County. The school felt it would not be fair to make a student athlete choose between being in the Homecoming court and playing an away basketball game. This would also put the girls ball team playing four nights in a row. The game was made up on February 6<sup>th</sup>, 2013.

Robertson County was scheduled to play Lexington Sayre on Saturday, February 2<sup>nd</sup>, 2013. The game was cancelled by Sayre, due to the same snowstorm that cancelled Silver Grove. There were no open prime time dates, for both schools, left in the season.

Robertson County School has never intentionally been out of compliance with Title IX. We scheduled according to the regulations. Weather, death, and only having six players led to a difficult second half of the season, in regards to scheduling. The school did its best to make sure the student athletes were allowed to play as many games as possible with the circumstances. The school did not want to deprive the athletes of games just because they could not be rescheduled on prime time dates.

The Saturday, Feb. 2 game with Portsmouth East was also changed due to the weather and played the next week. There were no other prime time days left to be able to use before the districts deadline.

Please grant the waiver for this problem. Thank you for your assistance.

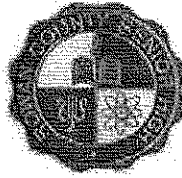

Dear Mr. Bilberry,

I am writing today to inform you about the beginning of the year and the end of the year Title IX scheduling issues that seemed to make our girls' team noncompliant with Prime Time scheduling under test two, total games – home and away.

I received a call on December 3<sup>rd</sup>, 2012 about our girls' team being under the required 40%. Upon investigating I found that the December 27<sup>th</sup> Lady Colonel Holiday Classic had not been placed on the Riherd's scoreboard for scheduling. That was immediately fixed and we scheduled directly afterwards. That tournament added 4 total games, 3 of which were primetime, taking our schedule, under test two, to over 41%.

When the team arrived at the Bourbon County tournament they were informed that one team dropped out of the tournament, which left a hole in our side of the bracket. The winner in the bracket would get four games in the tournament, but the team that moved to the losers side of our bracket would only get three. Unfortunately, the girls fell short against Pendleton County on December 27<sup>th</sup>. Due to this situation, the girls ended up with only 3 games in the tournament. Although this was in violation of the contract, it was done with no recourse for us. See "A" written in on the attached tournament bracket. I have included the contract for this tournament to show that we had reached the agreement in August and that it was not a rush fix to reach the 40% for compliance.

The second game cancelled was Feb 15<sup>th</sup> against Sheldon Clark. This game was scheduled to begin at 7 PM. Ice had formed on I-64 and a 5 car pile-up blocked both lanes of traffic preventing the Lady Cardinals from reaching Rowan County. At 8:15, after several calls to the state police it was determined that very bad weather was headed toward Inez and I-64 was still not opened for travel. With safety of the children in mind, it was agreed to cancel the game and get the kids off the roads before the bad weather set in. As you are aware, Inez is almost two hours from Morehead. This game was so late in the year that a reschedule date was impossible to attain. I have included the contract to show that the game has been scheduled since May of last year.

- The school failing to carry out the terms of the contract shall pay to the other the listed forfeit fee per contest remaining on the contract unless the contest(s) is/are canceled by mutual consent. It is the financial responsibility of the school failing to carry out the terms of the contract to pay the officials fees in addition to any applicable forfeit fee. If a forfeit fee is paid for cancellation of the contest after the first legal playing date, the victory/defeat shall be made part of the won-loss record of both teams and count on the limit of games for both teams. Forfeit Fee \$500

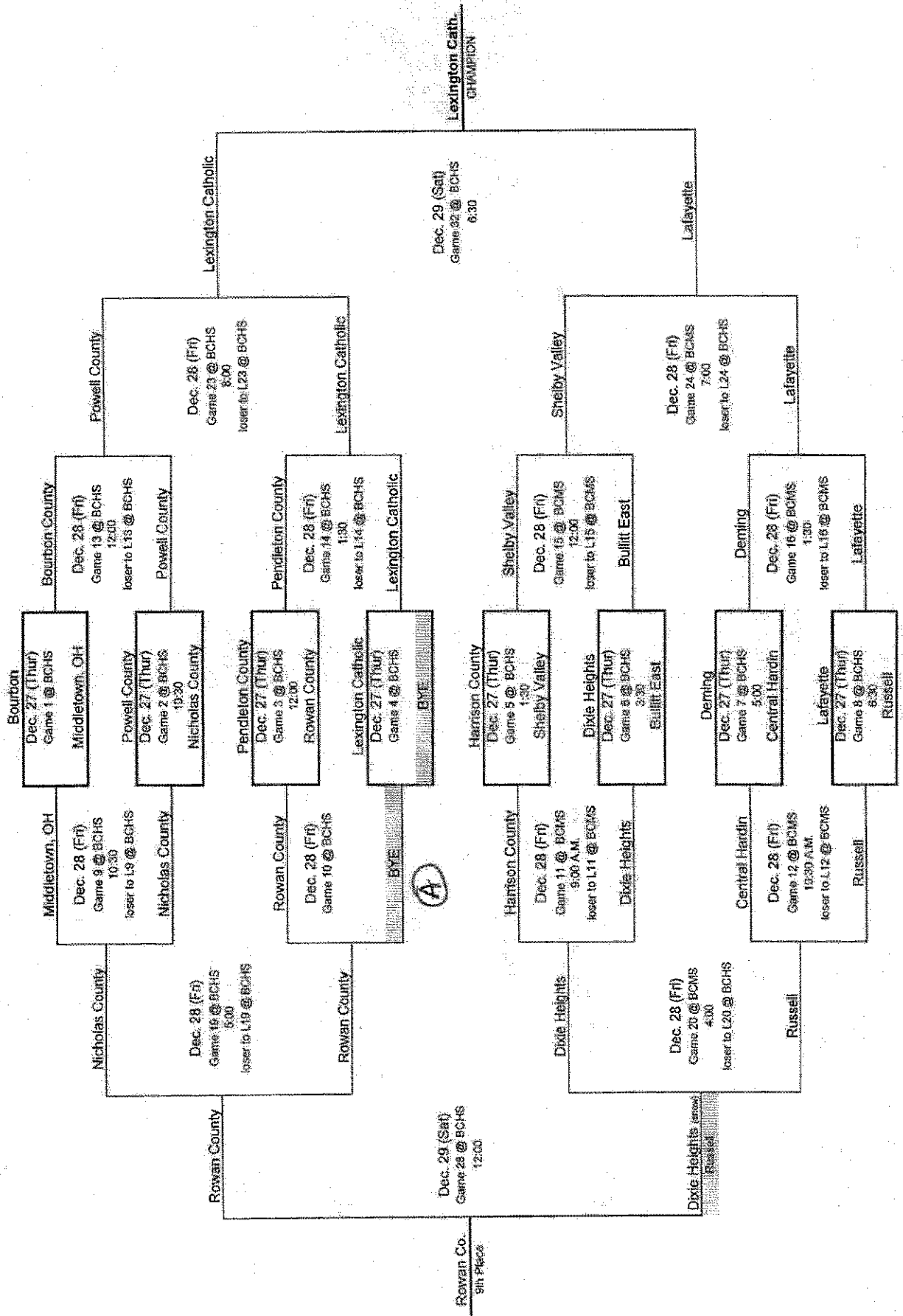

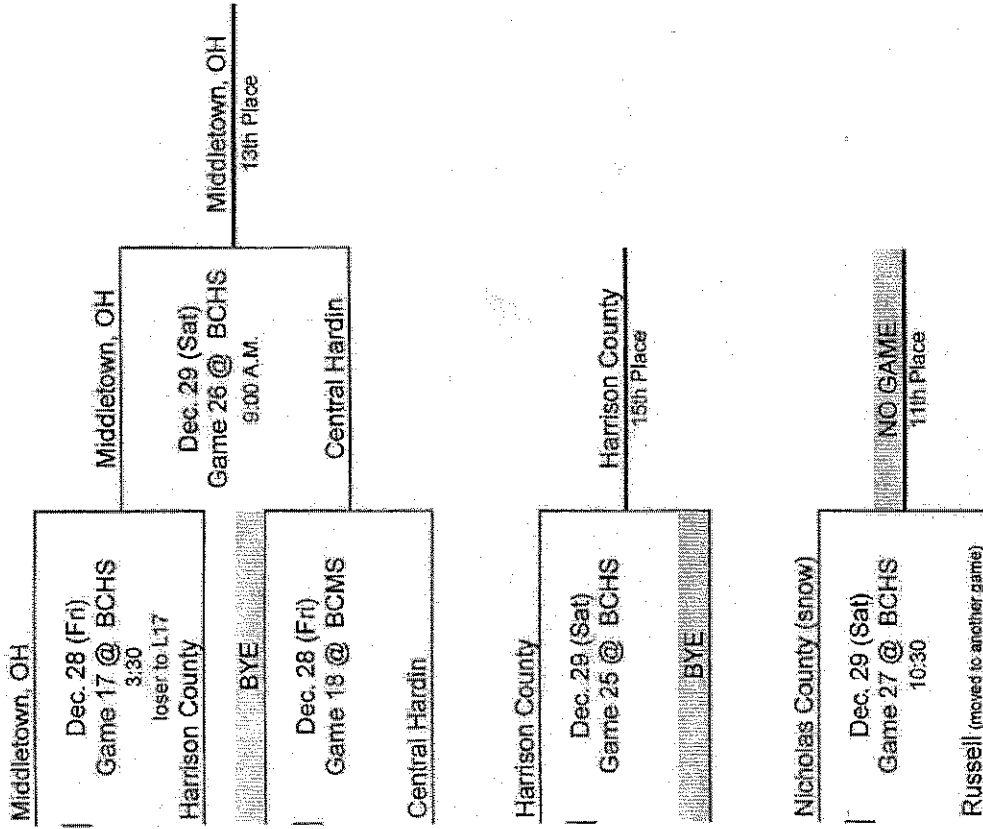

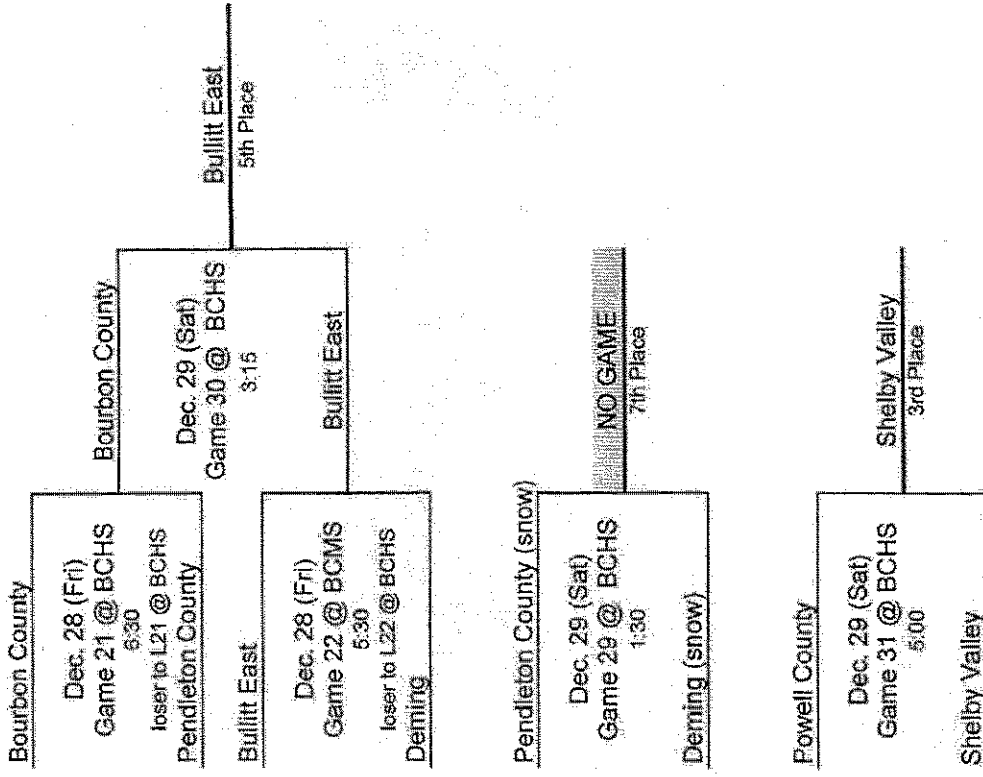
