V. Consent Calendar and Superintendent's Report

Dr. Hargens: "Chair Diane Porter, members of the Board; it is my pleasure to call your attention to a few items of special interest.

We are approximately five days away from testing and heading toward the end of the 2012–13 school year and approximately 90 days away from the start of the 2013–14 school year. This is really the time when we are closing one year and working to put the staffing and resources in place to begin a new year. I appreciate Chief Financial Officer Cordelia Hardin's leadership in the budget process to ensure that all of our dollars impact students.

The summer before last I was in North Carolina reading about 55,000 Degrees. What I recall was that 55,000 degrees is the temperature of a lightning strike. What it appeared to me to be was a great example of a community all rowing in the same direction toward a goal—with each player knowing their specific role and the contribution they need to make.

Our *Strategic Plan Vision* 2015 has as one of its four focus areas—Graduation and Beyond—and has a specific strategy—2.4—that speaks to this important collaboration. It also talks about creating a context where all students have a disposition for postsecondary education and are truly college and career ready. 55K has been a conversation-changer and a catalyst.

At Atkinson Elementary School, the kindergarten students, when asked the year that they will graduate ready for college—say 2025. The Jefferson County Public Education Foundation has funded college banners for our elementary schools. At many of our schools, teachers post outside their door the colleges and universities from which they graduated. A Western High School senior, who is a member of the Superintendent's Student Advisory Council, proudly announced that she was college and career ready and now was assisting her peers.

A data system designed in JCPS keeps track of students' status and informs interventions so they can provide extra time and support. This takes intentionality, and it also takes redirecting resources. And we are seeing progress. Last year, college and career readiness went up by 13 percentage points. Our target for this year is 51.7 percent and our preliminary data says we're on track. Graduation rate went up, and we are working toward our 55,000 Degrees goal.

We have maintained or improved attendance, and our suspensions are down.

U.S. News & World Report released its analysis of more than 18,000 high schools across the nation and more than half of JCPS high schools received national recognition. The publisher ranked schools using a three-step method developed by the American Institute for Research with data from 2010–11 reading and math achievement, the performance of the school's least-advantaged students, and the school's college readiness performance-based on Advanced Placement or International Baccalaureate test scores. A gold medal was awarded to high schools that met the requirements of all three steps and ranked in the top 500 schools nationally. At JCPS, these schools included Manual, Ballard, and Brown. A silver medal was awarded to schools that met the requirements of all three steps but weren't in the top 500—that included Male and Atherton. A bronze medal was awarded to schools that met the requirements for the first two steps—including Butler, Central, and three of our Priority Schools—Fairdale, Fern Creek, and Western.

Nationwide less than 25 percent of schools received a medal, whereas more than 50 percent of JCPS high schools were recognized.

And we all know that it all starts way before high school. The new accountability model gives each student a sense if they are on-track to be college and career ready. The Common Core Standards adopted last year in Kentucky make it clear what students are expected to know on each level.

We know that JCPS is the pipeline for achieving the goal of 55,000 in Louisville, and we take our responsibility very seriously. And we're looking forward to the presentation this evening about 55,000 Degrees.

At this time, Chair Porter, I recommend the consent calendar for your consideration."
