#### SAFETY ISSUES

- a) Site access to baseball and softball is being maintained
  - i) Summer sports practice schedule has been transmitted from owner to contractor. Owner and contractor to coordinate accessibility issues as needed.
  - ii) Heavy sidewalk work expected starting July 16 that will disrupt current access to baseball, softball and football field. Alternative gates to be used as needed. Contractor to continue coordinating with owner as needed.
- b) Football schedule has been released. First home game is scheduled for 9/6/13.
- Contractor stated that students and staff have been doing an excellent job of staying safe and away from job site.
- d) No other comments made by Owner or Contractor.

#### 11. ADDITIONAL ITEMS

- a) Data route from High School to Field House
  - i) Alternate route was proposed by subcontractor to boar a direct line from High School connection point southeast under parking lot to entry point of Field House at no additional cost.
  - ii) This avoids trenching parking lot and grass areas.
  - iii) Contractor proposes locating pull boxes as needed.
  - iv) Known obstacles have been noted by underground surveying agency and include power to parking lot light pole and storm water drain line, which should be easily avoided per the subcontractor.
  - v) Issue was reviewed with CMTA on site. Confirming RFI of final plan from contractor is expected.
- b) Electrical Floor boxes-locations to be reviewed after the meeting.
  - i) Location was determined for Health & Wellness Room 118 floor boxes(2) to be centered in the north-south direction and evenly spaced in the east-west direction.
  - ii) Apparent floor boxes shown in classrooms were identified as ceiling location
- c) Musco Field Lights start up is to be scheduled by contractor.
- d) Black top-topping and striping pricing and installation to start next week.
  - i) Site superintendent requested construction area of parking lot be done at a later date for best final product.
  - ii) Owner agreed and will coordinate.
- e) Door keying schedule

- i) Owner indicated this was sent to hardware subcontractor by email.
- ii) Any additional comments from hardware consultant are to be returned to Endeavor.
- iii) Endeavor requested this be reviewed by Hardware consultant if required.
- iv) Information emailed from owner to subcontractor to be shared with RTA and Endeavor.
- f) Electronic Door Information
  - i) RTA to verify all information has been submitted and reviewed.
- g) Electrical Contractor requested information for owner furnished equipment for coordination of installation and includes:
  - i) Ceiling projector mount product information.
  - ii) Ceiling projector location.
  - iii) Smart Board product information.
- h) Office 103
  - i) After the progress meeting, it was determined with the electrical contractor that the above counter receptacle/outlet shown in the drawings is to be located on the west end of the countertop for the fax machine.
- i) Alternate route for geo thermal loops to building.
  - i) Alternative route proposed by contractor is acceptable.
  - ii) Route is to avoid structural zones of influence.
  - iii) Route is to avoid foot print of future track.
  - iv) Changes are to be recorded in Record Drawings by contractor.
- j) Paint pattern as shown in the construction documents for press boxes were reviewed after the progress meeting.
  - i) Softball Press Box is to be blue.
  - ii) Football Press Box is to be white with blue bands.
- k) Concrete design strengths were discussed after the progress meeting.
  - i) Design strengths were found throughout the specifications and discussed by phone 6/7.
